

ORDINANCE NO. 2013-393

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS  
REPEALING ORDINANCE NO. 2013-392 AND AMENDING CHAPTER 8.20  
OF THE LOS ALTOS MUNICIPAL CODE PERTAINING TO PARKING  
RESTRICTIONS FOR ELECTRIC VEHICLE CHARGING STATIONS

WHEREAS, the City of Los Altos Municipal Code Chapter 8.20 addresses restrictions to public parking facilities; and

WHEREAS, the City adopted Ordinance 2013-392 amending Section 8.20.270 of the Municipal Code to add language to restrict parking at electric vehicle charging stations; and

WHEREAS, Section 8.20.270 of the Municipal Code pertained to Blue Curb Markings and therefore should not be amended to include language on electric vehicle charging stations; and

WHEREAS, this Ordinance is exempt from environmental review pursuant to Section 15061(b)(3) of the State Guidelines implementing the California Environmental Quality Act of 1970, as amended.

NOW THEREFORE, the City Council of the City of Los Altos does hereby ordain as follows:

**SECTION 1. REPEAL OF ORDINANCE 2013-392:** Ordinance 2013-392 that amended Section 8.20.270 of the Los Altos Municipal Code is hereby repealed in its entirety.

**SECTION 2. AMENDMENT OF CODE:** Los Altos Municipal Code Chapter 8.20 is hereby amended to add a new Section 8.20.265 to read as follows:

**“8.20.265 – Reserved Parking for Electric Vehicle Charging Station Use.**

When authorized signs are in place giving notice thereof, no person shall stop, stand, or park any vehicle in a spot demarcated as an electric vehicle charging station except when using the electric vehicle chargers, as indicated by sign.”


**SECTION 3. CONSTITUTIONALITY.** If any section, subsection, sentence, clause or phrase of this Code is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Code.

**SECTION 4. PUBLICATION.** This Ordinance shall be published as provided in Government Code section 36933.

**SECTION 5. EFFECTIVE DATE.** This Ordinance shall be effective upon the commencement of the thirty-first day following the adoption date.
