

RESOLUTION NO. 07-36
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS DECLARING
CANVASS OF RETURNS AND RESULTS OF THE GENERAL AND SPECIAL MUNICIPAL
ELECTION HELD ON NOVEMBER 6, 2007

WHEREAS, the City Council of the City of Los Altos duly called and ordered held in the City on Tuesday, November 6, 2007, a General Municipal Election pursuant to Section 10400-10418 of the California Elections Code, to fill three seats; and

WHEREAS, the City Council of the City of Los Altos duly called and ordered held in the City on Tuesday, November 6, 2007, a Special Municipal Election pursuant to Government Code Section 53724 and Election Code Section 9222, where residents were asked to vote on Measure O Communications Users Tax; and

WHEREAS, pursuant to the applicable provisions of the Elections Code of the State of California, the Registrar of Voters of the County of Santa Clara has duly canvassed the votes cast by the electors in the City of Los Altos upon the offices hereinafter set forth, and has certified to the City Council the results of the votes cast, which certification is attached as Exhibit "A" and incorporated by reference;

WHEREAS, pursuant to State Elections Code Section 15400, the City is required to accept the Statement of Election Results and declare the totals to be final results of the election;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LOS ALTOS THAT

1. The canvass by the Registrar of Voters as shown in Exhibit "A" and the results of the votes cast at the General Municipal Election and Special Election is hereby ratified, confirmed and approved.
2. The total numbers of votes cast in the City of Los Altos at the General and Special Municipal Election, is set forth in Exhibit "A." All absent voters' ballots have been duly received and canvassed in time, form and manner as required by law
