

RESOLUTION NO. 06-06

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS
AUTHORIZING THE SUBMITTAL OF PROPOSALS FOR NON-COMPETITIVE
FUNDS FROM SANTA CLARA COUNTY UNDER THE FEDERAL HOUSING
AND COMMUNITY DEVELOPMENT ACT FOR FISCAL YEAR 2006/2007**

WHEREAS, the City of Los Altos has previously entered into a Joint Powers Agreement with Santa Clara County to form an Urban County under the Housing and Community Development Act; and

WHEREAS, the City Council held duly noticed public hearings on February 28, 2006 and March 14 2006 on the allocation of funds under the Community Development Act; and

WHEREAS, the City Council finds and determines that the following proposals represent the community development needs in Los Altos.

NOW THEREFORE, BE IT RESOLVED, that staff is hereby authorized to submit proposals for the expenditures of CDBG funds in the amount of \$139,070 as described below:

BE IT RESOLVED THAT the final 2006/2007 CDBG funding allocations are provisioned as follows:

1. That the City's CDBG program is fully funded by the Federal government; and
2. That any unspent Capital Improvement Project funding shall be returned to the City.

BE IT RESOLVED THAT staff is authorized to submit the proposed amendments to the City's prior year allocations as described below:

1. Reprogram \$60,000 from (LA-05-42) ADA Access Improvements to the Springer/Foothill ADA Access project.

2. Transfer \$1,599.75 from (LA-05-31), and estimated balance of \$15,792 from (LA-05-41) ADA Stall Modifications–Downtown Plaza to (LA-07-51) Housing Rehabilitation Loans.

BE IT RESOLVED THAT the County is authorized to include revisions in the Housing Rehabilitation Exhibit I, FY 2006/2007 CDBG City/Country Contract, to include the following:

The County will reduce housing rehab loan amounts to Los Altos residents of no greater than \$50,000. This will allow for more Los Altos residents participating in the program with the available funds.

BE IT FURTHER RESOLVED THAT the City Manager is hereby authorized to execute standard CDBG contracts between the City and the non-profit agencies for FY 2006/2007.
