1. Design Review Commission Minutes

Approve minutes of the regular meeting of June 1, 2016.

DISCUSSION

2. 16-SC-08 – Via Builders Inc. – 581 University Avenue

Design review for a new two-story house. The project includes 1,425 square feet on the first story, 490 square feet on the second story, and a 416 square-foot detached garage. This project was continued from the May 4, 2016 meeting. *Project Planner: Gallegos*

Assistant Planner Gallegos presented the staff report, recommending approval of the project. Applicant Jonathan Fales from VIA Builders presented the application.

Residents Janet Corrigan, Doug Smith and John Corrigan spoke in opposition to the project.

Action: Upon a motion by Commissioner Kirik, seconded by Commissioner Harding, the Commission approved design review application 16-SC-08 per the staff report findings and conditions, with the following additional conditions:

- Record a deed restriction that the accessory structure shall not be used as a second living unit;
- Remove the windows from the garage; and
- Remove the plumbing and wet bar from the office in the accessory structure.

3. 16-SC-03 – M. Liang – 980 Golden Way

Design review for a new two-story house. The project includes 2,679 square feet on the first story and 1,324 square feet on the second story. *Project Planner: Dahl*

Planning Services Manager Dahl presented the staff report, recommending approval of the project. Applicant and designer G'lush Dada presented the application and said she simplified the design from French contemporary to contemporary.

Assistant Planner Davis presented the staff report, recommending approval of the project. Project architect Tim Chappelle and property owner Bill Fairey presented the application.
