**1. Design Review Commission Minutes**

Approve minutes of the regular meeting of August 3, 2016.

Action: Upon a motion by Commissioner Harding, seconded by Commissioner Zoufonoun, the Commission unanimously approved the minutes of the July 20, 2016 regular meeting as written.

**DISCUSSION**

**2. 16-SC-25 – D. Winklebleck – 1480 Elnora Court**

Design review for a two-story addition to an existing one-story house. The project includes 158 square feet on the first story and 609 square feet on the second story. *Project Planner: Gallegos*

Planning Services Manager Dahl presented the staff report for Assistant Planner Sean Gallegos, recommending the project be continued to address design concerns. Project designer Dan Winklebleck presented the application and requested approval. Property owner Doug Quist spoke in support of the project.

**3. 16-SC-26 – B. Oreizy – 930 Regent Drive**

Design Review for a two-story addition to an existing two-story house. The project includes an addition of 531 square feet on the first story and a new second story deck on the left side of the house. *Project Planner: Davis*

Assistant Planner Davis presented the staff report, recommending approval of the project. Project architect/applicant Bahi Oreizy presented the application.

- Eliminate the wetbar in the lower level bedroom.

**4. 16-SC-28 – Blome Architecture – 904 Madonna Way**

Design review for a two-story addition to an existing two-story house. The project includes 25 square feet on the first story and 132 square feet on the second story. *Project Planner: Gallegos*

Planning Services Manager Dahl presented the staff report for Assistant Planner Sean Gallegos, recommending approval of the project. Project architect Fred Wong presented the application.
