Barb O'Reilly, Los Altos resident, expressed thanks for the City's Climate Action Plan and recognition of climate change and in addition, encouraged increased education and public outreach to the public via the City website and through other outreach efforts.

Charley Pow, representing GreenTown Los Altos, ask for passage of a water ordinance based on the Santa Clara Valley Water District draft model ordinance and requested water usage data and encouragement of drought tolerant landscaping.
