ITEMS FOR CONSIDERATION/ACTION

1. Commission Minutes
Action: Upon a motion by Commissioner Lai, seconded by Vice President Satterlee, the Commission approved the minutes of the regular meeting of January 23, 2014 by a 4-0-1 vote, with Commissioner Corrigan absent.
2. Local Agency Investment Fund authorization
Action: The Commission continued the item to a date uncertain.
3. Affirm Setting a Property Based Levy with the County of \$76 for FY 2014/15
Action: Upon a motion by Vice President Satterlee, seconded by Secretary Pepper, the Commission approved the adoption of Resolution No. 2014-03, to affirm setting a special tax rate for library services with the County of \$76 for FY 2014/15 by a 4-0-1 vote, with Commissioner Corrigan absent.
4. Adoption of the Budget for Fiscal Year 2014/15
Deputy County Librarian Derek Wolfgram provided an overview of the Los Altos and Woodland libraries' services with a comparison between actual FY 2012/13 and projected FY 2013/14.

Action: Motion made by Commissioner Lai to approve the FY 2014/15 NCLA budget with book costs increased from \$25,000 to \$65,000. Motion died for a lack of second.

Vice President Satterlee opposed including funds in the budget for book costs.

Action: Upon a motion by Secretary Pepper, seconded by Commissioner Lai, the Commission approved the FY 2014/15 NCLA budget as proposed by a vote of 3-1-1, with Vice President Satterlee dissenting and Commissioner Corrigan absent.

Action: Upon a motion by Vice President Satterlee, seconded by Commissioner Lai, the Commission approved the adoption of Resolution No. 2014-05, setting the FY 2014/15 Appropriation Limit by a vote of 4-0-1, with Commissioner Corrigan absent.

5. Administrative Officer Somers noted that the NCLA Norms and Procedures updated February 13, 2012 specify that the NCLA regular meeting will be scheduled in the third and fourth quarters of the fiscal year, and recommends those dates be set by Commission action.
