1. **11-SC-33 – E. Ganitsky – 545 Rosita Avenue**

Design review for a new, two-story house. The project includes 2,002 square feet on the first floor and 1,448 square feet on the second floor. *Project Planner: Koo*

2. **11-SC-36 – M. Tom – 1598 Vineyard Drive**

Design review for first and second story additions. The project adds 279 square feet to the first floor and 546 square feet to the second floor. *Project Planner: Lacey*

3. **07-SC-38 – A. Penilla – 1960 Noel Drive**

Modification to an approved grading and landscape plan. The modification includes a proposal to install a retaining wall along the northwest property line and a revised landscape planting plan. *Project Planner: Lacey*

PLANNING COMMISSION'S ROLE

The Planning Commission advises the City Council on matters relating to land use and land development in Los Altos. This includes the development and implementation of the General Plan, Zoning Ordinance, and other land use regulations and recommendations on development applications.

The Planning Commission holds public hearings on certain requests for land use and development before making recommendations to the City Council. Two subcommittees of the Commission also exist as described below:

1. **BOARD OF ADJUSTMENTS**

The Board of Adjustments consists of three Commission members. The Board's function is to consider and vote on variance requests to land use regulations such as site area, setbacks, coverage, yards and other open spaces, height of structures, and fences. Decisions of approval and denial by the Board of Adjustments may be appealed to the Planning Commission.

2. **ARCHITECTURE AND SITE REVIEW COMMITTEE**

The Architecture and Site Review Committee consists of three Commission members. The Committee reviews two-story residential projects with regard to the Single-Family Residential Design Guidelines, decisions of which may be appealed to the Planning Commission. The Architecture and Site Review Committee reviews commercial and multiple-family projects for appropriate design and site planning, screening, landscaping, colors and materials, and makes recommendations regarding such matters to the Planning Commission and City Council.

Planning Commissioners are appointed by the City Council for a four-year term. The Commission is a voluntary position whose responsibility is to make decisions based on City regulations and plans for the overall good of the community.

When addressing the Commission, it is necessary to give your name and address for the record and use the microphone so that all present can hear your input.
