ITEMS FOR CONSIDERATION/ACTION

1. Minutes

On a motion by Commissioner Fenton, seconded by Commissioner Chester, the item is approved,. Passed 6-0.

2. 2016 Commission Elections

Suzanne Ambiel nominated for Jim Fenton for Chair. Jim Fenton nominated Wes Brinsfield for Chair. Wes Brinsfield and was elected as Chair for 2016/17. Passed 6-0. Randy Kreigh nominated Jim Fenton for Vice Chair. Jim Fenton nominated Suzanne Ambiel for Vice Chair. Suzanne Ambiel was elected Vice Chair for 2016/17. Passed 4-2.

3. <u>4880 El Camino Real – 16-D-01</u>

Planning staff provided a report regarding an application for a 21-unit multi-family condominium located at 4880 El Camino Real. The development will replace the previous Hunan Hose restaurant.

The BPAC provided suggestions for the applicant to consider which include: consider an increased amount of bike parking/racks in the storage area to be balanced with the number of vehicles parked at the site; ensure that the ramp to the garage provides skid resistance finish in case cyclists choose to ride the ramp, consider pedestrian indicator warnings for vehicles leaving the garage, consider internal flooring that is easy to clean in case cyclists choose to bring their bikes inside; maintain at least a seven- wide hallway for bikes.

4. 962 Acacia Avenue

Planning staff provided a report regarding a Use Permit application and Code Amendment for two residential units at 962 Acacia Avenue.

The BPAC provided three suggestions for the applicant to consider:

- 1. Consider the sidewalk connectivity of the site to adjacent improvements/land uses
- 2. Consider increasing the amount of internal and external bicycle storage
- 3. Consider providing an illuminated walkway for residential access

5. <u>Downtown Bicycle Parking</u>

Staff provided an update regarding downtown bicycle counts performed by staff and Commissioners Brinsfield and Kriegh. These counts considered bikes that were parked U-racks, artistic racks, and unofficial racks (temporary or parked on poles/trees). It was recommended that a downtown bike parking map be updated.

Staff provided an overview of bicycle and pedestrian related injuries between 2013 and 2014.
