CALL TO ORDER

Roll Call: Attending were Carl Hagenmaier (Chairperson), Bill Crook, Henry Pastorelli and Randy Rhody. Absent were Scott Chan, Jim Fenton, and Chris Hlavka

Public Comments:

Jeannie Bruins was in attendance and commented on item #4.

Discussion:

- 1. Approval of March 19, 2008 BPAC meeting minutes (Carl)(Decide) Minutes were approved 4-0.
- Bike To Work Day May 15 (Discuss, Decide)
 Henry has volunteered to be the lead for BTWD and will attend the pickup meeting on 5/13.
 Henry, Randy, and Carl will be volunteering.
 Larry will arrange for two tables, which Randy will pick up 5/14.
 Carl has the signs to put on Foothill.
 Chris has the BPAC banner.
 Carl will seek donations from Draegers. Randy suggested less water and some bananas.
 Henry will hit up the bike shops.

- 4. Stevens Creek Trail Feasibility Study Update (Randy, Henry) (Discuss) Larry has received the draft final from Alta. However, they still need to do a walk-through of the far side of 85. Jeannie is trying to schedule this for Friday. Within 5 days of the walkthrough, Larry should have the final draft final copy. There was some discussion of the steps BPAC will take when the copy is available. The members suggested to Jeannie that BPAC would want to review primarily in order to advocate for the trail. We reminded her that we have to make public notice for any meeting we have, but deferred to the Task Force to determine the specific review process they will follow. We also discussed the merits of a working session with the Council, and whether this should occur on the same day it is on the council agenda, or sometime before.
- Traffic Commission update (Scott) (Inform) Bill reported that TC had reported to Council that they were not satisifed with the San Antonio crossing lights.
- 6. VTA BPAC update (Carl) (Inform) County Airports and Roads made a presentation of their working expressway plan. There are two projects on Foothill at Loyola corners: one to widen the bridge, the second to widen the

roadway shoulders under the bridge. Carl reported that at the mayor's meeting it was revealed that there is traffic circulation plan in development for Loyola corners.
