### CALL TO ORDER

Amgen Tour of California is looking for volunteers.  
¼ cent tax fund was presented to the BPAC  
Grant Rd between Foothill and Fremont repaving project ('06-'07 project) which will be funded in part by VTA STP. There may be some inconsistency between the description we have and VTA's (Larry will check this) "Grant Road Repair" Larry thinks they will be at 35% point in July or August 2006.  
VTA published new bike maps, which were distributed.  
VTA has some money to update bus stops. Scott has been working to get Grant & Oak and Grant & Wharton fixed (part of SRTS). He thinks the Grant & Oak
