

## CITY OF LOS ALTOS CITY COUNCIL MEETING April 14, 2015

**SUBJECT:** Appropriate \$60,985 to the Main Library Parking Lot, Project 13-16 from the General Fund; award the Base Bid plus Add Alternates No. 1 and 2 for the Main Library Parking Lot, Project 13-16 to Silicon Valley Paving, Inc. for \$110,053; and authorize the City Manager to execute a contract on behalf of the City

### BACKGROUND

On September 9, 2014, City Council accepted a recommendation to modify the scope of work for the Main Library Parking Lot, Project 13-16 and to re-bid the project with add alternatives to reduce project costs. This project is intended to improve the safe movement of vehicles and pedestrians in the library parking lot drive aisle off of San Antonio Road. The project will remove three spaces closest to the intersection and relocate them nearer to the satellite parking lot near the soccer field.

#### PREVIOUS COUNCIL CONSIDERATION

#### DISCUSSION

In May 2014, the design and specifications of the project were completed and the project was advertised on May 16, 2014. On June 16, 2014, two bids were received and opened in a public session. At the June 24, 2014 City Council meeting, it was recommended that \$142,438 be appropriated to the project and awarded to the lowest bidder. The initial estimated budget for the project was estimated at a lower cost and therefore the project already needed additional funding upon award of the project. As a result to the recommendations for the project, Council unanimously rejected all bids as excessive and directed the Library Commission to review the project.

The project was reviewed at the Library Commission at its July 1, 2014 meeting. At the September 9, 2014 City Council meeting, it was recommended to accept the Library Commission's recommendation to change the scope of work to lower the cost and re-bid the project. City Council accepted the recommendations and directed staff to also include add alternates for the additional work.

Revisions of the design and specifications were initiated per Council's direction and then completed in early January 2015. The Base Bid for the revised project scope of work included site preparation, asphalt paving and striping, site concrete, and landscaping. Add Alternate No. 1 included crosswalk striping, concrete sidewalk, and pervious pavers at crosswalk. Add Alternate No. 2 included additional clearing and grubbing, grading, asphalt paving, concrete curb, wheel stops, pervious pavers, tree protection and saw-cutting to construct three new parking stalls to replace the three parking stalls that were removed closest to San Antonio Road. Add Alternate No. 3 includes a 12" median curb.

The project was put out for bid on January 26, 2015. On March 20, 2015, three bids were received and opened in a public session. The bid result summary is included as Attachment 1.

It is recommended that award of the Base Bid plus Add Alternates No. 1 and 2 be made to Silicon Valley Paving, Inc., the lowest responsive and responsible bidder.

Add Alternate No. 3 is not recommended for award since immediate action was taken to install the temporary flex curb and is currently working efficiently.

Silicon Valley Paving, Inc. has no deficiencies against its General Contractor's license and no active safety violations per a review of the Occupational Safety and Health Administration (OSHA). The company has been in business for 18 years and has completed similar projects for various agencies.
