

**SUBJECT**: Review the City's Special Event sponsorship levels, and direct staff accordingly

# BACKGROUND

The City of Los Altos has a long history of special events. Chapter 9.25 of the Los Altos Municipal Code outlines requirements for conducting a special event and requires that a permit be obtained for special events to be held on City property. This permit is accompanied by a fee, currently \$2,045 for a new event and \$875 for an ongoing event. Special events must also cover costs for all City departmental service charges in connection with the event (i.e., salaries/benefits of City employees assigned to work at the special event).

Section 9.25.090 of the Municipal Code defines three types of events: A, B and C. Type A events are privately funded and must pay 100% of all fees and charges. Type B events are co-sponsored by the City and must pay 50% of all fees and charges. Type C events are also co-sponsored by the City and are not required to pay any fees or charges to the City. Section 9.25.090 also specifies that City sponsorship for Type B and C events is set by Resolution. The Special Event Resolution was last approved in 2010 (Attachment 1).

Events which are solely funded and sponsored by the City are exempt from paying any fees or charges set by the City Council.

On October 14, 2014 and December 9, 2014, students from Los Altos High School requested the City Council consider the Los Altos High School Homecoming Parade as a Type C event and waive all fees and charges.

There are several options for Council to consider:

- 1. Leave all sponsorship at their current levels
- 2. Adjust one or more of the sponsorship levels, which will require a Resolution adopting the new sponsorship levels
- 3. Remove one or more of the events from the list; this action will move the event(s) to the Type A category and any future events will be required to pay all fees and charges

## PUBLIC CONTACT

Each of the charter organizations for each event has been notified of this report.

Posting of the meeting agenda serves as notice to the general public.

### FISCAL/RESOURCE IMPACT

For FY 2013/14, the City subsidized the various events in a total amount of \$81,166. This amount represents lost revenue to offset actual expenditures. Should an event be moved from Level B to Level C, the subsidy would be double the current amount.

#### **RESOLUTION NO. 2010-32**

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS REPEALING AND REPLACING RESOLUTION 2008-17 SETTING SPECIAL EVENT SPONSORSHIP PURSUANT TO CHAPTER 9.25.090

WHEREAS, the City Council recognizes that special events enhance the City's lifestyle and provide benefits to the City; and

WHEREAS, the City Council finds that the sponsorship of certain long standing special events provides a community benefit; and

WHEREAS, the Los Altos Municipal Code Section 9.25.090 specifies that special event sponsorship for Type B and Type C events shall be set by Resolution of the City Council; and

WHEREAS, on April 8, 2008 Council adopted Resolution No. 2008-17 authorizing sponsorship for certain events and since that date two additional Type B events have been identified.

NOW THEREFORE, BE IT RESOLVED by the City Council that:

- 1. Resolution 2008-17, adopted April 8, 2010, is hereby repealed in its entirety.
- 2. Authorizes the following levels of sponsorship for special events:
