SUBJECT: Adopt Resolution No. 2015-33, accepting completion of the Annual Street Slurry Seal, Project TS-01004 and authorize the Public Works Director to record a Notice of Completion as required by law

BACKGROUND

On May 12, 2015, the City Council awarded the Annual Street Slurry Seal, Project TS-01004, to Bond Blacktop, Inc. The work included traffic control, mobilization, slurry seal, and striping of 20 residential and collector street segments throughout the City.

PREVIOUS COUNCIL CONSIDERATION

DISCUSSION

Project TS-01004 was completed in accordance with the contract plans and specifications, and complies with the Standard Specifications of the City of Los Altos. The final cost of the construction contract with Bond Blacktop, Inc. was \$179,933.92, including two change orders to eliminate the cost-sharing work with City of Mountain View and to adjust the final difference in quantities for the various locations, which results in a net decrease of \$9,955.58. All work was completed and is acceptable.

Recording of the Notice of Completion begins the 35-day lien-filing period for subcontractors and suppliers. At the end of the 35-day period, the City releases the 5% retention amount to the contractor if no liens are filed. Attachment 1 is the proposed resolution of acceptance (Resolution No. 2015-33).
