SUBJECT:

Introduce and waive further reading of Ordinance No. 2015-416, repealing Chapter 3.16 of the Los Altos Municipal Code pertaining to informal bid procedures for public projects

BACKGROUND

In 1987, the City Council adopted Ordinance No. 87-168, thereby electing that the City become subject to the Uniform Construction Cost Accounting Procedures set forth in the Uniform Public Construction Cost Accounting Act ("Act"). The Act allows local agencies to perform public works projects up to \$45,000 if the agency follows certain cost accounting procedures, which were established by the California Uniform Public Construction Cost Accounting Commission ("Commission") and are detailed in the Commission's Accounting Policies and Procedures Manual. The Act is codified in Public Contract Code § 22000 et seq. and describes the formal and informal bidding procedures, project dollar thresholds, bidding and noticing requirements, process for rejection of bids and other mandates. Participation in the program is voluntary and the City may withdraw at any time.

DISCUSSION

It is recommended that the City withdraw its participation from the Act for several reasons. First, adherence to the cost accounting procedures in the Act has become increasingly burdensome because of more complex accounting procedures and additional oversight from the Commission. The City may face civil liability from contractors and from the Commission if the City is does not strictly comply with each and every technical requirement of the Act. In addition, the Act contains liberal protest procedures that allow contractors who are not awarded projects to challenge the City's adherence to the requirements of the Act. Regardless of their merit, such protests may be used to create additional procedural hurdles for the City and thereby delay projects as a result. Finally, the City has not participated in alternative bidding procedures for nearly 20 years.

With this action, procurement of all City public work projects will continue to be competitively bid.

ORDINANCE NO. 2015-416

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS REPEALING IN ITS ENTIRETY LOS ALTOS MUNICIPAL CODE CHAPTER 3.16 PERTAINING TO INFORMAL BID PROCEDURES FOR PUBLIC PROJECTS AND REPEALING IN THEIR ENTIRETY ORDINANCES NOS. 87-168 AND 96-349 AND RESOLUTIONS NOS. 84-59 AND 87-12 PERTAINING TO INFORMAL BID PROCEDURES UNDER THE UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT

WHEREAS, California Public Contract Code, section 22000 *et seq.*, known as the Uniform Public Construction Cost Accounting Act ("Act"), established a uniform cost accounting standard: and

WHEREAS, the Act established the California Uniform Public Construction Cost Accounting Commission, which developed uniform public construction cost accounting procedures for implementation by local public agencies in the performance of or in the contracting for construction of public projects; and

WHEREAS, the alternative bidding procedures provided for under the Act allow local public agencies to perform work by force account and let to contract by informal procedures public projects under certain circumstances and pursuant to the Commission's review; and

WHEREAS, many years ago the City Council elected, under Public Contract Code section 22030, to become subject to the uniform public construction cost accounting procedures set forth in the Act and to the Commission's policies and procedures manual and cost accounting review procedures; and

WHEREAS, there is no historical evidence that the City has participated in alternative bidding procedures for almost twenty (20) years; and

WHEREAS, repealing Los Altos Municipal Code Chapter 3.16 pertaining to informal bid procedures for public projects and repealing Ordinances Nos. 87-168 and 96-349 and Resolutions Nos. 84-59 and 87-12 pertaining to informal bid procedures under the Act is necessary to avoid any confusion regarding the review and/or reporting requirement required by the Act and the Commission; and

WHEREAS, the procurement of all City public work projects, as defined by the California Public Contract Code, are competitively bid; and

WHEREAS, this Ordinance is exempt from environmental review pursuant to Section 15061(b)(3) of the State Guidelines implementing the California Environmental Quality Act of 1970, as amended.

NOW THEREFORE, the City Council of the City of Los Altos does hereby ordain as follows:

SECTION 1. AMENDMENT OF CODE: Chapter 3.16, entitled "Contracts for Public Projects" is hereby repealed in its entirety.

SECTION 2. REPEAL OF ORDINANCES: Ordinance No. 87-168, adopted March 24, 1987, and Ordinance No. 96-349, adopted July 9, 1996, are hereby repealed in their entirety.

SECTION 3. REPEAL OF RESOLUTIONS: Resolution No. 84-59, adopted September 11, 1984, and R esolution No. 87-12, adopted March 10, 1987, are hereby repealed in their entirety.

SECTION 4. ELECTION TO WITHDRAW: This Ordinance No. 2015-416 serves as the City's election to withdraw from the Act.

SECTION 5. CONSTITUTIONALITY. If any section, subsection, sentence, clause or phrase of this code is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this code.

SECTION 6. PUBLICATION. This ordinance shall be published as provided in Government Code section 36933.

SECTION 7. EFFECTIVE DATE. This ordinance shall be effective upon the commencement of the thirty-first day following the adoption date.
