5. Receive an update on two community meetings related to senior needs and the Charter and structure of the Senior Commission; discuss the Charter and structure of the Senior Commission and existing vacancies, and direct staff accordingly

Mayor Pro Tem Prochnow presented the subcommittee update.

#### Public Comments

Los Altos resident Paul Gonella expressed concerns regarding over-regulation of the Senior Commission and encouraged maintaining the Senior Commission.

Los Altos resident Carlos Shaw supported maintaining the Commission as currently structured.

Los Altos resident Frank Martin disputed claims that the Senior Commission is dysfunctional, disrespectful and has violated the Brown Act.

Los Altos resident Pat Marriott encouraged the Council to give all Commissions more autonomy.

Los Altos resident Andrea Eaton questioned whether the Council would be conducting the same process for all Commissions.

6. Receive a final report from the Environmental Commission on Community Choice Energy, and direct staff accordingly

Assistant City Manager Logan presented the report. Environmental Commissioners Gary Hedden and Laura Teksler presented the Commission's final report.

#### Public Comments

Los Altos residents Natalie Elefant, Maddy McBirney, Barbara O'Reilly, Karen Janowski, Nancy Bremeau, Barbara Kyser, Barbara Weinstein, Eitan Fenson, Kevin O'Reilly, Susan Russell, Vladimir Ivanovic, Sam Harding, Karl Danz and Don Bray, Gary Latshaw, representing Sierra Club, Michael McTighe, representing GreenTown Los Altos, Mike Balma and Julie Rose, representing the Chamber of Commerce, supported joining Silicon Valley Clean Energy Authority.

Councilmember Satterlee disclosed ex parte communications with Karl and Paula Danz, Karen Janowski and Margie Suozzo. Mayor Bruins disclosed ex parte communications with Margie Suozzo, Karen Janowski, Eitan Fenson and Jeff Byron.

<u>Action</u>: Council members generally supported joining Silicon Valley Clean Energy Authority and directed staff to move forward with the necessary steps to join the Authority.

Mayor Bruins called for a recess at 9:00 p.m. The meeting resumed at 9:10 p.m.

7. Discuss the Commercial Wayfinding Sign Program, Project CD-01002 and either award the Base Bid and Add Alternate No. 1 for Commercial Wayfinding Sign Program, Project CD-01002 to VKK Signmakers in the amount of \$123,697.31 and authorize the City Manager to execute a contract on behalf of the City or reject all bids, and direct staff accordingly

Engineering Services Manager Lamm presented the report.

Los Altos resident Roberta Phillips questioned the purpose of the project.

Los Altos resident Maddy McBirney expressed concerns over the design of some of the signs.

Nancy Dunaway, representing Los Altos Village Association, and Julie Rose, representing the Chamber of Commerce, supported awarding the project.

Los Altos resident Anita Enander encouraged the City to avoid adding sign poles in sidewalks.

Action: Upon a motion by Councilmember Satterlee, seconded by Mayor Pro Tem Prochnow, the Council awarded the Base Bid and Add Alternate No. 1 for Commercial Wayfinding Sign Program, Project CD-01002 to VKK Signmakers in the amount of \$123,697.31 and authorized the City Manager to execute a contract on behalf of the City, with the following direction to staff: 1) examine the alignment of the directional arrow on sign E2; and 2) examine the placement of signs E9, E10 and E11 in relation to other signs in the area, by the following vote: AYES: Bruins, Pepper, Prochnow and Satterlee; NOES: None; ABSENT: Mordo; ABSTAIN: None.

8. Receive a Downtown Parking Management Plan Short-Term Parking Strategies and Implementation Schedule update and adopt Resolution No. 2016-02, establishing Graduated Parking Fines, Procedures and Penalties

Economic Development Manager Quinn presented the report.

Action: Upon a motion by Councilmember Satterlee, seconded by Mayor Pro Tem Prochnow, the Council adopted Resolution No. 2016-02, establishing Graduated Parking Fines, Procedures and Penalties, as amended to state that first and second violations are set at \$54.50 and the third and subsequent violations are set as \$151.40, by the following vote: AYES: Bruins, Pepper, Prochnow and Satterlee; NOES: None; ABSENT: Mordo; ABSTAIN: None.
