SUBJECT: Adopt Resolution No. 2016-04, accepting completion of the Miramonte/Covington

Pedestrian Improvements, Project TS-01021 and authorize the Public Works

Director to record a Notice of Completion as required by law

BACKGROUND

On August 25, 2015, the City Council awarded the Miramonte/Covington Pedestrian Improvements, Project TS-01021, to Golden Bay Construction, Inc. The work included the installation of pedestrian refuge curbs, ADA-compliant curb ramps, signing and striping, utility relocation, electrical conduits, and pull boxes.

EXISTING POLICY

Capital Improvement Program (CIP) Project TS-01021

PREVIOUS COUNCIL CONSIDERATION

November 10, 2008; November 10, 2009; February 14, 2012; May 22, 2012; January 8, 2013; May 16, 2013; June 9, 2015; and August 25, 2015

DISCUSSION

Project TS-01021 was completed in accordance with the contract plans and specifications, and complies with the Standard Specifications of the City of Los Altos. The final cost of the construction contract with Golden Bay Construction, Inc. is \$173,496.63. The work included one change order to improve the drainage surface between the driveway of 1010 Covington Road and the newly improved area at the southeast corner of Miramonte Avenue and Covington Road to avoid ponding next to the resident's driveway. All work was completed and is acceptable.

Recording of the Notice of Completion begins the 35-day lien-filing period for subcontractors and suppliers. At the end of the 35-day period, the City releases the 5% retention amount to the contractor if no liens are filed. Attachment 1 is the proposed resolution of acceptance (Resolution No. 2016-04).

The total project savings of \$7,539.54 will return to the unfunded CIP funds.
