**SUBJECT**: Adopt Resolution No. 2016-05, accepting completion of the Grant Park Community Center Roof Replacement, Project CF-01008 and authorize the Public Work Director to record a Notice to Completion as required by law

## BACKGROUND

On August 25, 2015, the City Council awarded the Grant Park Community Center Roof Replacement, Project CF-01008 to Pioneer Contractors, Inc. for \$141,000. This project replaced the entire roof of the Community Center and improved the safety of the building.

## DISCUSSION

The work on Project CF-01008 complies with the Standard Specifications of the City of Los Altos. All work was completed and is acceptable.

Recording of the Notice of Completion begins the 35-day lien-filing period for subcontractors and suppliers. At the end of the 35-day period, the City releases the 5% retention amount to the contractor if no liens are filed. Attachment 1 is the proposed resolution of acceptance (Resolution No. 2016-05).
