SUBJECT: Approve recommendations related to the Senior Commission, and direct staff accordingly

BACKGROUND

On March 23, 2010, the City Council approved the charter and constitution of a pilot Senior Committee. The Committee was originally made up of nine individuals, six from Los Altos and three from Los Altos Hills.

On April 26, 2011, the Council approved establishing the Senior Committee as the Senior Commission. The Los Altos Municipal Code identifies the purpose of the Senior Commission including advising both Los Altos and Los Altos Hills City Councils on senior needs and issues.

On March 26, 2013, the number of members was reduced to seven, with five being appointed by Los Altos and two being appointed by Los Altos Hills.

PREVIOUS COUNCIL CONSIDERATION

DISCUSSION

During its short history, it has been difficult to recruit and retain Senior Commission members and therefore, there have been a number of changes in membership. Most recently in March 2015, there were four new Los Altos members appointed with only one incumbent, continuing Los Altos member. One Los Altos Hills resident was appointed in March 2015 after a long-standing vacancy, with the other Los Altos Hills member resigning in June 2015 prior to the end of her term creating a new vacancy that was filled in October 2015.

In July 2015 during the Council's mid-year retreat, the status of the Senior Commission and the extent to which the Senior Commission members were working effectively together was discussed. At that time, the Council requested an outside facilitator be secured to assist the group in developing meeting protocols and positive communication strategies. A facilitator worked with the commission on this endeavor and the meeting protocols were approved on September 14, 2015. Two of the newly appointed Los Altos members have since resigned their appointments effective September 15 and November 13, 2015 respectively, and a third Los Altos member resigned effective February 26, 2016.

On December 8, 2015, Council discussed the Charter and structure of the Senior Commission and decided to appoint an ad hoc committee of Mayor Bruins and Mayor Pro Tem Prochnow to host meetings with the Senior Commission and meetings at Hillview Community Center and Grant Park to assess the structure and Charter of the Senior Commission.

The ad hoc committee hosted community meetings at Grant Park on January 13, 2016 in the Multi-Purpose Room and at Hillview Community Center on January 15, 2016 in the Senior Program Room. These meetings were well attended, included seniors who are not current program participants, and focused on gathering input on what works well and what needs attention with respect to programs, facilities, and overall needs of senior members of the community. The input was captured and is summarized in Attachment A. Members of the Senior Commission and Los Altos Hills Mayor John Harpootlian were in attendance at each of these meetings.

The ad hoc committee met with the Senior Commission on February 1, 2016. The discussion focused on how Commissioners perceived the roles of the Commission, of the Chair and of staff.

On February 22, 2016, the ad hoc committee met with Los Altos Hills Mayor Harpootlian, Councilmember Corrigan, Town Manager Cahill and Los Altos City Manager Somers. Discussions focused on a review of findings, solicitation of feedback and collaborative development of draft recommendations. The group concurred with the following conclusions:

- Current programs offer a variety of benefits (recreational, educational, social) and are enjoyed and valued by participants
- Los Altos and Los Altos Hills should continue to work together at a staff level to provide a robust set of services and programs for seniors in our communities
- More direct participant input into program and service offerings would be beneficial
- Outreach to seniors needs to be reinvigorated, increasing awareness of programs and services offered directly by our cities and providing linkages to other local agencies serving seniors

RECOMMENDATION

We believe that facilitating and expanding the opportunities for our senior community to provide input and ideas to our respective cities in a less structured form of communication and idea sharing will bring about a positive result for all and will enhance our collective commitment to serving our senior community. Therefore, we make the following recommendations:

- Replace the Senior Commission with "advisory forums" at each location where Senior programs are offered to:
 - o Provide an opportunity for seniors to identify, share, and discuss ideas that pertain to City services and programs;
 - o Provide an opportunity for staff to receive direct feedback on specific programs, projects and services as well as to keep seniors informed on topics relevant to them;
 - o Forums to be hosted by staff, scheduled on a regular frequency, and encourage dropin participation,
- Direct staff to reinvigorate outreach to seniors

We believe the benefits of this approach include:

- Increased responsiveness to senior needs and ideas
- More organic input that is unencumbered by Brown Act regulations
- A community engagement forum that provides for senior members of our communities to provide input before, during and after development of programs and services
