SUBJECT: 2015/16 ENVIRONMENTAL COMMISSION ACCOMPLISHMENTS

Before you are the Environmental Commission's 2015/16 completed Work Plan and Accomplishments that cover the period from April 2015 - April 2016 and the Draft 2016/17 Environmental Commission Work Plan.

The 2015/16 Work Plan contained five target areas. Here are the Accomplishment highlights:

- 1. Climate Action Plan (CAP)
 - a. Reviewed Draft 2014 CAP Report to Council and provided staff with questions, comments and suggestions
 - b. Developed an Environmental Resources Dashboard to track City-wide usage of electricity, natural gas, water, vehicle miles traveled and resulting production of greenhouse gas (GHG) emissions. Dashboard was posted on City website in January 2016.
 - c. Hosted CCE Community Meeting with Silicon Valley Community Choice Energy Partnership and produced and distributed resource flyer.
 - d. Evaluation of and reports to Council and community on feasibility of Community Choice Energy (CCE) as an initiative for meeting CAP goals. Recommendation to Council to join Silicon Valley Clean Energy Authority (SVCEA) in January 2016.
 - e. Council completed steps to join SVCEA in February 2016 and appointed Mayor Bruins as Board Director and Commissioner Don Bray as alternate.
- 2. Water Conservation
 - a. Engaged with staff to develop and recommend to Council a Water Conservation Resolution which set forth unified water reduction measures consistent with the provisions issued by Governor Brown's Executive Order for emergency drought measures, Cal Water Service Schedule No. 14-1 and Santa Clara Valley Water District model Water Conservation Ordinance for reduction and conservation of water.
 - b. Council adopted the Water Conservation Resolution No. 2015-15

- c. Engaged with staff to review municipal City water reduction measures and recommend a three-tiered approach to Council
- d. Provided outreach and education on water reduction and conservation to the community at the Farmers' Market and conducted various community outreach efforts in coordination with staff
- e. Water usage is a metric included in the Environmental Resources Dashboard. In addition; the City website contains robust content on water conservation information and resources.
- 3. Solid Waste and Construction and Debris Diversion
 - a. The draft Solid Waste Ordinance and draft Construction and Debris (C&D) Ordinance were reviewed with staff in December 2015 and April 2016 respectively. Comments and suggestions offered to staff were incorporated into the draft Ordinances.
- 4. Green Business Practices
 - a. A well-attended workshop that included a presentation by Santa Clara County Environmental Services was convened to encourage local businesses to pursue green business certification. Speakers who hold green business certifications presented at the workshop.
- 5. Community Outreach
 - a. The Environmental Commission and Green Initiatives website page improvements were implemented along with timely updates
 - b. Environmental Resources Dashboard added to website
 - c. CCE webpage developed, updated and provides robust resource links
 - d. The Environmental Commission Chair and Vice Chair made presentations and arranged for speakers on the topic of Community Choice Energy to local service clubs
 - e. Commissioners served as resource to the community on environmental topics related to the Work Plan

There are five target areas in the draft 2016/17 work plan

- 1. Climate Action Plan
 - a. Work with staff to support and promote CCE community education and outreach including serving as speakers to local community groups
 - b. Serve as resource to SVCEA Board Director Bruins for issues or topics that may come before the Board including policy and program decisions; perform related projects as assigned by Council in support of CCE implementation
 - c. Support the Council SVCEA Board member and provide assistance as needed
 - d. Work with staff on a CAP implementation plan, the preparation for a comprehensive evaluation of CAP progress, and the addition of CCE as one of the greenhouse gas (GHG) mitigation measures
 - e. Investigate and recommend measures to improve energy efficiency, e.g. by encouraging programs offered by PG&E, Acterra, Energy Upgrade California
 - f. Investigate best practices for building codes and planning requirements to enhance energy efficiency, electric car charging readiness, solar panel installation and other green building measures

- g. Investigate and recommend measures to reduce transportation GHG emissions, e.g. more biking/walking to schools, employee car share, shuttle options
- h. Maintain and enhance the Environmental Resources Dashboard and continue to investigate and attempt to understand or resolve the VMT (vehicle miles traveled) data conflicts
- i. Work with staff on the tree inventory and the list of recommended trees
- 2. Water Conservation & Stormwater Management
 - a. Engage with staff on water conservation and drought related measures
 - b. Continue to track water usage via the Environmental Resources Dashboard
 - c. Support staff in development of stormwater discharge planning, ordinance development, reporting and compliance requirements
 - d. Support staff to develop green infrastructure measures as applicable
- 3. Solid Waste Diversion
 - a. Continue to provide support and input to staff to finalize adoption by Council of the C&D ordinance
 - b. Engage with staff periodically to review progress on solid waste diversion metrics and meeting the diversion goals for the community
 - c. Arrange for annual update report from Mission Trail Waste Systems
- 4. Visioning Process
 - a. Engage with staff to support and provide an environmental perspective to the visioning process for development of a Downtown Plan for City of Los Altos
- 5. Community Outreach
 - a. Engage with the community to support understanding and confidence in CCE implementation and SVCEA; report back to the Council as necessary
 - b. Continue to implement website improvements and add content and resources on environmental issues related to the Work Plan
 - c. Continue to invite interesting speakers to EC meetings
