Honorable council members,

Thank you for your continued support of the Homestead Road Safe Routes to School project. I have reviewed the staff report and attachments prepared for your April 9th meeting.

We are concerned that the project does NOT address one of the TOP concerns that parents have raised throughout the process. Specifically, how will student cyclists safely access the extended pathway (on Homestead) from the Grant Road bike lane?

Your proposed plans (painted bike merge sharrow and a bike left turn pocket) are insufficient. We rightly fear this will preserve the UNSAFE status quo especially in the morning rush hour for students who use the pathway and that we will continue to see them, even after your proposed improvements are made, ride on "the wrong side of the road" on Grant Road in the morning for safety reasons as they approach the pathway.

We need your utmost attention on this matter, to ensure that the Homestead Road Safe Routes to School project provides a safe way for students to use the Grant Road bike lane in the morning and safely access the proposed extended pathway. At least one too many students have been injured in this location. We have shared more detailed concerns with staff throughout the process about this location, as well as some improvement ideas. Multiple safe route parent leaders have been available to meet with staff (and continue to be available). We need staff's engineering expertise to recommend a solution to our problem. We look forward to staff presenting such a solution that the community can embrace at the April 9th council meeting.

I have some other suggested edits on your letter to the county. The suggestions are to ensure accuracy of the letter, and completeness of the content. Please see attached - the edits are in red, and I have included comments in the left margin that explain the reason for each suggested edit.

Also, I support the additional staff recommendations in the staff report (immediately add a flashing beacon at Homestead/Fallen Leaf, contact property owners at shopping complex to consider installation of stop signs/limit lines at

their egress driveways, and explore cellular based network switches for the Homestead/Trader Joe's traffic signal to provide a link with the county expressway network).

If you have any questions about this feedback or want to discuss further, please feel free to reach out to me. It's important for the safety of our children to finalize this letter to the county on April 9th with an included solution for how students will **SAFELY** access the proposed extended Homestead Road pathway from the Grant Road bike lane in the morning).

Let's continue to move the overall Homestead Road Safe Routes to School project forward!!! Again, thank you so much for your continued support of this project!

Subject: Homestead Road Safe Routes to School Planning Phase Project Requested Project Enhancements

Thank you for your leadership in advancing the planning phase of the Homestead Road Safe Routes to School project between Foothill Expressway and <u>Macy Avenue</u> <u>Hollenbeck Avenue/N. Stelling Road.</u> The work performed by the County of Santa Clara has been phenomenal in coordinating feedback from the interested project cities, Los Altos, Cupertino, and Sunnyvale.

During the final community outreach meeting on February 25, 2019, the County staff presented a conceptual plan line drawing for residents to provide feedback on. While the conceptual plan line was developed in conjunction with input from each of the project cities, several items remain pending within the City of Los Altos. We are requesting your support to help ensure that these items are included within the final project documents so that when future grant funding is pursued for implementation of the capital improvement phase of the project, the project can be properly scoped and cost estimate accurately reflect project costs.

#### 1) Vineyard Drive Sidewalk and Traffic Calming Improvements

Vineyard Drive is the extension of Homestead Road on the west side of Foothill Expressway, but it is not currently an element of the Homestead Road – Safe Routes to School Planning Phase project. During the three two community outreach meetings Los Altos residents continually expressed concern regarding this missing addition to the project. Los Altos student residents are served by the same schools within the Cities of Cupertino-Sunnyvale (Cupertino Middle School) and Sunnyvale Cupertino (Homestead High School) and Vineyard Drive between Deodara Drive and Foothill Expressway currently lacks sidewalk and traffic calming measures to encourage bicycling and walking as attractive commute alternatives.

The conceptual plan line prepared by the City recommend the installation of a new sidewalk along the west side of Vineyard Drive, two new speed humps to help encourage a reduction in vehicle speeds, and a new multi-way stop at Deodara Drive and Vineyard Drive.

The City requests that your office support the addition of Vineyard Drive formally into the project work scope and more importantly, project limits, so that future grant funding can

be used to help implement these improvements. The conceptual plan line work is already completed for these enhancements, so addition of Vineyard Drive should be feasible without any increases to the current planning phase project.

Further, the Measure B project being planned for 280/Foothill with a Homestead auxiliary lane impacts the safety on the school route and we request that safe routes to school be a priority component of that project.

# 2) Homestead Road and Grant Road Triangle Improvements

The Foothill Expressway-Homestead Road-Grant Road Triangle is being identified as challenging location for all travel modes to traverse through due to the existing roadway geometry and lack of continuous facilities for bicyclists and pedestrians. The project currently proposes an extension of the multi-use pathway along the north side of Homestead Road-Grant Road to fill this gap. For student cyclists to enter this extended pathway as they ride to school in the morning, the proposed in-roadway merge sharrows from the Grant Road bike lane to the proposed bike pocket in the median is not sufficient and we propose [INSERT WHAT THE CITY PROPOSES TO ADDRESS THE PARENT SAFETY CONCERN AT THIS LOCATION].

The current proposal though does not address the missing bicycle lane facility along the southbound approach of Grant Road.

The City requests that your office support the addition of a widening of Grant Road north of Homestead Road-Foothill Expressway for approximately 200-FT. The widening will allow the existing bicycle lane facility on Grant Road to continue the length of the street and connect to new bicycle lane facilities already proposed in the project within the Triangle helping to improve mobility options for the community.

# 3) Homestead Road and El Sereno Avenue Capacity Improvements

The northbound approach the Homestead Road and El Sereno Avenue intersection currently lacks a dedicated northbound left turn lane for access into the private property on the south side of the intersection (Chevron). Left turns are currently allowed to the private property from the through lane that also services Foothill Expressway. When any motorists attempt to turn left into the gas station it results in queue impacts and a loss of roadway efficiency.

The City prepared a conceptual plan line for the Los Altos portion of Homestead Road improvements and recommended installation of a northbound left turn lane at the Homestead Road and El Sereno Avenue intersection, but this improvement was not

The City requests that your office support the addition of the proposed northbound left tum lane at the intersection of Homestead Road and El Sereno Avenue to help improve roadway operations along Homestead Road.

# 4) Traffic Signal Coordination on Homestead Road

The City of Los Altos currently lacks city-wide communications infrastructure and an ability to coordinate traffic signal timing with the County of Santa Clara expressway network. To improve coordination, the city requests that fiber optic infrastructure be included along Homestead Road from Foothill Expressway, to Trader Joe's traffic signal, and to the proposed traffic signal at Homestead Road and Fallen Leaf so that adaptive traffic signal coordination along Homestead Road can be implemented in conjunction with the County of Santa Clara Expressway network.

The city also requests that the county lead a feasibility study to further extend coordination of signals along Homestead Road to include signals at Belleville Way/Barranca Dr., 85 off ramp/ Maxine Ave., and Bernardo Ave./85 on ramp. Having traffic signal coordination on Homestead Road across the jurisdictional between the expressway and 85 will enable better flow of traffic, and less strain on cyclists and pedestrians.

Once again, the City of Los Altos thanks you for your leadership in helping to advance the planning phase of the Homestead Road Safe Routes to School project. We are confident that this effort will help result in successful future grant opportunities for the Cities of Los Altos, Cupertino, and Sunnyvale. The above requested improvements along Homestead Road within the City of Los Altos will help ensure a successful capital project for our shared communities.
