10. <u>Resolution No. 2019-17: 389 First Street Design Review</u>: Adopt Resolution No. 2019-17, which will approve Design Review application 17-D-02 and Subdivision application 17-SD-02 per the listed findings and conditions for a new, mixed-use building with ten residential units and 2,100 square feet of office at 385, 387 and 389 First Street

Steve Johnson and Jeff Potts presented the application and revised plans.

Action: Upon a motion by Councilmember Bruins, seconded by Councilmember Enander, the Council adopted Resolution No. 2019-17 approving Design Review application 17-D-02 and Subdivision application 17-SD-02 per the listed findings and conditions for a new, mixed-use building with ten residential units and 2,100 square feet of office at 385, 387 and 389 First Street, with the following modification to add Condition 1.E stating that the height of the elevator and stair tower shall be no more than 12 feet above the roof deck so long as it is compliant with the Americans with Disabilities Act (ADA) and if the access cannot be made compliant with the ADA, the applicant shall revise the plans to eliminate the rooftop deck and those revised plans shall be the approved plans, and directed the applicant to work with staff to revise the plans to stagger the tower, implement glass wall for the rooftop deck and to develop side elevations with expansion joints or possibly a paint treatment to diminish the overall massing of the right elevation, by the following vote: AYES: Bruins, Enander, Lee Eng, Pepper; NOES: None; ABSTAIN: None; ABSENT: Fligor.
