December 8, 2020 Council reorganization

The proposed schedule includes cancelling the second regular meeting in July and the first regular meeting in August for a summer break, the second regular meeting in November (which is the Tuesday before Thanksgiving) and the second regular meeting in December.

The proposed schedule also includes moving the Council reorganization from the first Tuesday in December to the second Tuesday. This is due to the fact that December 1st is only 28 days after the November 3 City Council election date and the Registrar of Voters has 30 days to certify the results of the election. As such, it is proposed to move the Council reorganization and the December regular meeting back one week to ensure that the City has the certified results of the election.

Options
