Policy Question(s) for Council Consideration:

Does the Council wish to appoint the applicants to serve on the Environmental Commission and the Complete Streets Commission or continue to recruit?

Summary:

- Two (2) applications were received for the one (1) vacancy on the Environmental Commission although one of the applicants also expressed interest in the Complete Streets Commission.
- Two (2) applications were received for the three (3) vacancies on the Complete Streets Commission.

Staff Recommendation:

Appoint the applicants to fill the vacancies on the Environmental Commission and the Complete Streets Commission.



Subject: Commission Appointments –

Environmental Commission – Complete Streets Commission

Purpose

To fill vacancies on the Environmental Commission and Complete Streets Commission

Background

The City Council appoints individuals to serve on the various City Commissions and one Committee.

Except for Senior and Youth Commissioners, members are appointed to four-year terms and may serve a total of two consecutive terms plus the fulfillment of an unexpired term should they be so appointed.

In this case the appointment is to fill one (1) unexpired term on the Environmental Commission, ending March 2022, and one (1) unexpired term ending March 2022; two (2) full terms expiring March 2024 on the Complete Streets Commission.

Discussion/Analysis

Currently there is one (1) vacancy on the Environmental Commission (expiring March 2022), and three vacancies on the Complete Streets Commission with one (1) term expiring March 2022; two (2) terms expiring in March 2024.

Options

1) Appoint one of the applicants to serve on the Environmental Commission and two of the applicants to serve on the Complete Streets Commission

Advantages: Fills the position on the Environmental Commission and two of the three (3) vacancies on the Complete Streets Commission.

Disadvantages: None identified

2) Inquire if one of the Environmental Commission applicants are interested in serving on the Complete Streets Commission and, if so, appoint one of the applicants to serve on the Environmental Commission and appoint three (3) applicants to serve on the Complete Streets Commission

Advantages: Fills all vacancies on the Environmental Commission and Complete Streets Commission.

Disadvantages: None identified

3) Take no action and continue to accept applications for the vacancy

Advantages: None Identified

Disadvantages: Leaves vacancies on the Commission
