Action: By written ballot, the Council appointed Nelvin Gee and Freddie Wheeler to four-year terms expiring September 2023 and Eric Steinle to the unexpired portion of a term expiring September 2021 on the Library Commission. Resolution No. 2019-40: History Museum Grant Application: Resolution No. 2019-40 Adopted approving the Los Altos History Museum's application for a County of Santa Clara County Historic grant for the Los Altos History Museum Historical Figures in Los Altos Exhibit project; delegating authority to the Los Altos History Museum Executive Director to sign and submit the grant application on behalf of the City of Los Altos; and committing the project property to the project for a period of at least twenty years
- 3. Ordinance No. 2019-458: Density Bonus Regulations: Ordinance No. 2019-458 adopted to amend Section 14.28.040.F of the Los Altos Municipal Code regarding incentive standards

5. <u>Construction Contract: On-Call Sanitary Sewer Spot Repairs and CCTV Inspection Services:</u>
Authorize the City Manager to execute a not-to-exceed contract with EPS Inc. dba Express Plumbing, in the amount of \$100,000 to provide on-call sanitary sewer spot repairs and CCTV inspection services (G. Gabler)

#### **DISCUSSION ITEMS**

 Ordinance No. 2019-462: Commercial Retail Sales District amendments: Adopt Ordinance No. 2019-462 amending the list of permitted and conditional uses in the CRS (Commercial Retail Sales) Zone District.

<u>Public Comment:</u> The Council heard comments from Jon Baer, Kim Mosely, Abby Ahrens, and Mayra Fernandez.

<u>Action:</u> Upon motion by Council member Enander and second by Vice Mayor Pepper the Council adopted Ordinance Number 2019-462 as presented. AYES: <u>Bruins</u>, Enander, Fligor, Lee Eng and Pepper; NOES: <u>Bruins</u>; ABSTAIN: None; ABSENT: None.

Action: Motion made by Councilmember Enander and seconded by Vice Mayor Pepper to direct staff to draft further amendments to the CRS Zone District to: 1) clearly ban "call centers;" 2) revise Section 14.4.8.030B to separate out animal clinics; 3) revise Section D to limiting Type 1 personal services and continue exclusion from fronting on Main, First, and State Streets but allowing them above the ground floor or elsewhere in the CRS zone and allow all Type 2 uses everywhere in the zone; 4) determine the appropriate location for Section 14.48.040. A after identifying its purpose and how it comports with the General Plan; and 5) Section C to restore an exception which would preclude day care centers on First Street.

Councilmember Bruins offered an amendment, which was accepted, to ban "call centers and the like" and to determine whether Section 14.48.040.A is needed and if so, the appropriate location. The motion, as amended, passed unanimously.

Mayor Lee Eng recessed the meeting at 8:55 p.m. The meeting resumed at 9:05 p.m.

AYES: Enander, Fligor, Lee Eng and Pepper; NOES: Bruins; ABSTAIN: None; ABSENT: None.

7. <u>Delegate to League of California Cities Annual Conference and Business Meeting</u>: Designate Councilmembers as Delegate and Alternate for the purpose of attending and voting at the League of California Cities Annual Conference and Business Meeting October 16-18, 2019 in Long Beach (J. Maginot)

Action: The Council unanimously appointed Mayor Lee Eng as delegate and Council member Fligor as alternate.

8. <u>Discussion of Hiring a Lobbyist</u>: Discuss hiring a lobbyist and determine how the Council would like to proceed (C. Jordan)

Action: The Council majority, members Bruins, Fligor and Vice Mayor Pepper, indicated their opposition to the City retaining a lobbyist and determined that no further action was necessary on this matter.

Action: Upon motion by Council member Fligor and second by Vice-Mayor Pepper, the Council unanimously agreed to form a Legislation sub-committee to be appointed by the incoming Mayor at the annual reorganization meeting in December.

9. <u>City of Los Altos Council participant in UrbanPlan for Communities workshop</u>: Select a participant and alternate of the Los Altos City Council to attend the UrbanPlan for Communities workshop (A. Carnesecca)
