## Dear Los Altos City Council Members,

I recently participated in a 21 Day Racial Equity Habit Forming Challenge cosponsored by the Palo Alto Unified School District and the city of Palo Alto. A key takeaway from this experience is that we all have a role to play as social justice allies and should start by debunking stereotypes when we see them occurring. And a key step in debunking stereotypes is to first recognize and acknowledge our own biases, whether explicit or implicit, so that we are more conscientious of our actions, both large and small, and their impacts. Political leaders, business leaders, teachers and other mentors within our communities can have an even greater impact when they examine their own biases.

Councilmember Lee Eng accepted a position of leadership in our community by winning a seat on the Los Altos City Council. As a leader, her actions and comments will often be scrutinized by others and she will face criticism for her choices. Her constituents have the right to express their criticism as Mr. Moos did. Councilmember Lee Eng may not enjoy the criticism she receives, but listening to it is part of the deal she accepted as a member of the City Council. As a community mentor it is even more important that she lead by example and as such, while I appreciate her willingness to start mediation to assist in resolving this issue, I still believe she should take this opportunity to help our community address and improve racial equity as a social justice ally by apologizing to Mr. Moos for their ongoing conflict. Leadership is not always easy and often requires acknowledging mistakes.

I would also strongly encourage Councilmember Lee Eng and the Los Altos City Council to consider pursuing a similar venture as the 21 Day Racial Equity Challenge with the Mountain View/Los Altos High School District and Los Altos School District communities. It could help pave a path forward for our community to continue honest dialogs about racial inequities and suggest actions our community members can take to prevent similar conflicts in the future.

## Dear Councilmembers,

I am writing in support of Kenan Moos, a young Los Altos man who has wrongly been accused of acting improperly in communicating with Councilmember Lee Eng. I continue to be disappointed that Councilmembers Lee Eng has refused to respond to the many constituents who have spoken out about this incident and has failed to reach out to Mr. Moos for a conversation. The amount of time that this has taken up inside and outside of council meetings simply because Lee Eng refuses to acknowledge the harm her words her caused is incredible. It is time for Lee Eng to act. She should apologize and if she is afraid to apologize because of the potential for a defamation claim, private mediation is a solution. A private mediator, agreed upon by the parties or chosen a majority of the council, can help the parties have an honest conversation and reach some resolution. If Lee Eng is unwilling to do anything, then I believe she cannot be an effective councilmember and should resign.

Some of Lee Eng's supporters say that anyone would have felt threatened receiving such a text and that she had a right to be afraid. Of course that is the issue. Would they have been afraid if the text had come from a white man or woman? Would Councilmember Lee Eng have felt the need to announce that she was concerned about herself or her family? Numerous studies show that black men, and young black men especially, are perceived as more threatening than white men in the same circumstances. This is the essence of implicit bias. Even if you do not see yourself as racist, you may have unrecognized thoughts and emotions that cause you to see black men as more dangerous than white men. We need to call out implicit bias when we see it - in ourselves or in others. This is one of those times.

Please do the right thing for Mr. Moos and for the good of our city.
