- Partnered with Los Altos School District


#### Welcome to Los Altos Chinese After School!



# **Traffic Management Plan**

A major traffic concern expressed to FCC was over cars departing the church, through the neighborhood, to El Monte Ave.


- Traffic Flow:
  - Parents picking up students arrive along Lincoln Ave. and depart via Sherman St. or Lincoln Ave.
  - Est. 65% of students will use Lincoln/Burke because they live in N. Los Altos & Los Altos Hills.
- Arrivals and Departures:

Foothills Congregational Church

Inited Church of Christ – Los Altos

- Students are dropped off in vans from each school.
- Student pick-up ranges from 3:30 to 6:00 PM.
- 75% of student are siblings forming natural carpools.

*Take-away:* We calculate that 47 cars are necessary to pick up the children over the afternoon, and that fewer than 25 departures would be along University Ave during this time.



### **Student Safety**


#### • Traffic Plan Commitment:

- Parents will sign a commitment at the beginning of each school year to abide by the traffic plan and acknowledging:
  - No parking on Orange Ave.
  - Fines up to expulsion for non-compliance

#### • Pick-Up Protocol:

- Parents will use sidewalks for access.
- A staff member / traffic monitor will be on hand to sign-out the student.
- Outdoor Play Space:
  - Examining options to enclose the courtyard for each class' use (see images)
  - FCC will provide an alternative space in the Parish Hall as timing permits and weather require.

Respect for Neighbors of the Church
Los Altos Chinese School wants to show respect for the neighbors of Foothills Congregational Church and therefore requires the following from all parents of currently enrolled students.
1. Under no circumstances will any parent or authorized person drop off or picking up a student from the facilities of
the Foothills Congregational Church to park their vehicles on Orange Ave. No Parking on Orange Ave at all time!
All drop-offs and pickups shall be made on the Lincoln Ave side of the Church. Failure to do so will be given a
courtesy warning for the first offense, a fine of \$50.00 for the second offense, and the third offense will result in
termination of your child's enrollment from LACS for the academic or school year.
2. All parents and /or authorized person for drop-off /pick-up students(s) must agree to obey LACS/Foothill Church
specified traffic flow around the neighborhood, including the applicable speed limits.
3. LACS/Foothill Church require all car traffics to make a U-Turn at the end of Lincoln Avenue, turn left - return onto
Lincoln Avenue then turn right at the Orange Ave intersection to exit.
4. LACS will issue a parking permit for each car you plan to use for student drop-off/pick-up. The permit must be
visibly placed on the front righthand side window of the car when you arrive and exit Foothills Congregational
Church.
5. Parents or authorized pick-up person must sign out for the student(s) and enter the time of day on the LACS sign-out
log.

## Modification of the Original Application

LACS and FCC have made changes to the application to respond to the concerns and requests of the neighbors as well as responds to request from Complete Streets Commission and Planning Commission. They are as follows:



Reducing enrollment from 90 to 75

Restricted hours to 12PM to 6PM



Added a traffic monitor



Added driver placards



Safe outdoor play space



### **COVID-19** Changes

LACS is currently operating after school classes in a virtual capacity.

Use of FCC will follow all local and state public health guidelines for children's programs in addition to the requirements of the Conditional Use Permit.
