Good Evening,

I support the resolution put forth by Council today.

I want to thank Council for clearing Keenan's name in this matter.

Today, on the 1 year anniversary of George Floyd's murder, I hope that we can all reflect on how much we've learned over the past 12 months.

For some, our eyes were opened for the very first time, to the subtle and not so subtle racism that's an everyday reality for people of color, and most especially for Black people in our country and around the globe.

For others, we are finally starting to feel heard, while also waking up to the dozens of ways in which we have learned to cope with and compensate for the never-ending racist assaults that we face—from micro-aggressions disguised as "humor," to systemic inequities like lower home appraisals and higher interest rates, to more egregious—yet no less common—police stops while driving in our own neighborhoods, and sadly (and most terrifying), fearing for the lives of our Black sons in particular, whenever they are out of our sight, and especially once they've reached adolescence because, the reality is, Black skin—especially on boys and men—is seen as a threat in and of itself.

Part of navigating though life as a Black person is knowing that your very presence often puts others on edge and accordingly, feeling obligated to 'put others at ease' through a variety tactics, all intended to communicate: I am not dangerous, I am friendly, I belong here, etc.

Council's resolution rightly rejects attributing any *threat* to Keenan's texts, where in fact, no threat was ever made.

It is well understood that there was a *perceived threat*. But that perception was, simply put: incorrect, caused by implicit bias, and based on the deeply-ingrained trope of the "dangerous Black man" which permeates our entire society, and infects all of our minds.

So many harmful actions are unintentional, but once harm is pointed out its incumbent upon all of us to do better.

Maybe the most important take away from this whole situation is: we are all in the process of learning and un-learning long-held, harmful and destructive ways of thinking and operating.

There is no shame in making mistakes, and there is no shame in apologizing and moving on. Ultimately, I think what we all want is a world were everyone can feel safe, welcome, valued and *believed*. And where we are free to make mistakes, apologize, listen, learn, grow and continue becoming better and better versions of ourselves for the benefit of everyone.





Mayor Fligor, Vice-Mayor Enander, Councilmember Lee Eng, Councilmember Meadows, & Councilmember Weinberg,

On behalf of Los Altos for Racial Equity (LARE), I would like to express support for Resolution 2021-24. I am satisfied that this resolution completely exonerates Kenan Moos of any wrongdoing during the Nov. 24 council meeting.

LARE believes this Resolution is critical in achieving closure to the violations to Council Norms and law that occurred during the Nov. 24 meeting.

Councilmember Lee Eng **violated Council Norms** when she read her personal text messages during a City Council meeting. There are no such norms prohibiting the public from sending emails or text messages to Councilmembers. The onus is on Councilmembers to abide by Council Norms.

Councilmember Lee Eng then **violated the Brown Act and the First Amendment** [1][2], which protect the public's right to criticise individual public officials and employees, not just public bodies. She did this when she implied that she and her family had been threatened through text messages. The actual text messages from Kenan Moos expressed *disappointment* with her. Her defense that "I never said that I had been threatened" is only partially true. It is true that she never *explicitly* stated that. But everyone in the Nov. 24 council meeting - the Councilmembers, Attorney Jolie Houston, and the public, understood her words to mean she had been threatened. Mayor Pepper and other Councilmembers expressed their disapproval of what they perceived to be threatening behavior. Attorney Houston encouraged her to forward the emails to the police, believing that something illegal had occurred. Councilmember Lee Eng never corrected them then, or in the 6 months since then. She used her words to *imply* that she had been threatened. Councilmember Lee Eng's supporters continue to call in to meetings to demand that Kenan Moos apologize for threatening her. They still believe the lie that she allowed to grow. The Council can NOT allow a Councilmember to silence public disagreement by false implications.

On top of that, Councilmember Lee Eng has now given interviews to Fox News & The Daily Mail, which has resulted in actual threats to Kenan Moos. This has gone too far without any action.

We expect a 4-1 vote in passing this Resolution. Anything less would be allowing the silencing of public criticism and an erosion of our democratic ideals.
