**CALL MEETING TO ORDER**

At 7:00 p.m. Mayor Enander called the meeting to order.

Mayor Enander announced that City Manager England was delayed, and Assistant City Manager Jon Maginot will be Acting City Manager while he arrives.

## PUBLIC HEARING

3. **4350 El Camino Real Multiple Family Development Project; 19-D-01, 19-UP-01 and 19-SD-01** - Multiple-Family Design Review, Conditional Use Permit and Tentative Subdivision map for a new multiple-family development with a five-story building with 47 condominium units along El Camino Real with two levels of underground parking. The proposal includes seven affordable units with four moderate-income units and three very-low-income units, and a density bonus with development incentives to allow for increased building height and a reduced parking aisle width. A Mitigated Negative Declaration with Mitigation Monitoring and Reporting Program in compliance with the California Environmental Quality Act (CEQA) will be considered. (R. Hayagreev)

City Manager Engeland joined the meeting and Radha Hayagreev, Senior Contract Planner, gave a Staff presentation to Council.

Angie Galatolo, developer of 4350 El Camino Real along with David Kornfield, developer's consultant and Alex Seidel, developer's architect provided a presentation to Council.

Council Member Fligor, Vice Mayor Meadows and Mayor Enander asked questions to the Applicant and Staff.

Council Member Weinberg disclosed that his client hired BKF Engineers, which worked on 4350 El Camino Real, as an expert witness in a legal case but he has not been in a financial relationship with the company. Mayor Enander and Council Member Lee Eng disclosed that they had conversation with the applicant regarding story poles but no conversations regarding this development. Vice Mayor Meadows disclosed that she saw this first at a Planning Commission 4 years ago. Council Member Fligor disclosed that she has had no conversations with the applicant.

The following members of the Public spoke: Frank Martin, Greg Stewart, Anne Paulson, Abby Ahrens, Roberta Philips, Donald Gardner, Wendy, David Feld, Jeremy McCabe, Allison, Sergey Finkelstein, Renee Rashid, and Nancy Martin.

Angie Galatolo, owner of 4350 El Camino Real, responded to some public comments.

Council Member Fligor, Vice Mayor Meadows, Council Member Weinberg, Council Member Lee Eng, and Mayor Enander asked further questions to the applicant and provided additional comments.

Following a motion by Mayor Enander, seconded by Council Member Lee Eng, the Council adopted a mitigated negative declaration and approving the design review, conditional use permit and subdivision applications for a forty-seven unit multiple family development project at 4350 El Camino Real subject to the following changes:

- Condition 37: to be amended as specified by City attorney to account for the uncertainty with respect to the current, as-built size of the sewer
- Condition 38: to be amended by Staff to accommodate instruction for mitigating construction parking to minimize impact on Los Altos Ave and adjacent streets
- Condition 31; to be amended to have the Below Market Rate Deed Restriction increased from 55 to 99 years

- Applicant will work with staff to alter the landscape plan for the required common open space to ensure it meets code
- Roof deck amenity will be removed, reducing the elevator height
- Condition 17; to be amended to include language 'as verified by the Development Services Director

Motion was approved with the following roll call vote:

Environmental Commission Subcommittee composed of Tom Hecht, Don Weiden and Laura Teksler, presented to Council.

Council Member Fligor, Council Member Weinberg, Vice Mayor Meadows, Council Member Lee Eng and Mayor Enander asked clarifying questions. City Manager Engeland and City Attorney Houston provide clarifications.

Mayor Enander asked clarifying questions to the Environmental Subcommittee.

Mayor Enander moved to direct the Environmental Subcommittee to stop work on Reach Codes and allow the California State codes to take over in January 2023 which was seconded by Council Member Lee Eng.

Council Member Fligor, Vice Mayor Meadows, and Council Member Weinberg provided further comments.

Motion failed 2-3 with the following roll call vote:

Council Member Weinberg moved to adopt the first three recommendations, seconded by Council Member Fligor, as presented in the Staff report. Vice Mayor Meadows requested a friendly amendment to include the fourth recommendation in the staff report, which was accepted.
