Hi,

I am struggling with the theater proposal. What is included is so different from details that have been published in NextDoor which included promises of a parking garage and one poster stating the City would garner increased property taxes.

This actual written proposal doesn't appear to offer either.

It appears to be asking for the Council to agree in Principle:

 City will lease land to the Los Altos Theater Group at minimal lease (what is minimal?);
Ongoing subsidy to the Los Altos Theater Group to operate the building: "It is common for municipal performing arts centers to require an annual operating subsidy to help cover maintenance and utilities." (is this subsidy then paying for the ground lease?);

4) A waiver of any net new parking to support the theater;

5) Agreement to a net loss of parking where the building footprint eliminates parking or fund any replacement parking through some other means; and that

6) The City wants a 'municipal performing arts center'

And then they want \$50K to continue down this path.

I believe the cart is clearly in front of the horse.

First, does the City want a 'municipal performing arts center'? While I have heard the concept of a new theater, this is the first time I am aware it has been called a municipal performing arts center.

Second, before investing any City money, I believe the Los Altos Stage Company, proposed operators of the building, should be submitting their financial feasibility study showing the operating costs and assumed revenues.

I have tried to search out that sort of information, but have had no luck. I only have newspaper articles to go on that the Mountain View Performing Arts Center is heavily subsidized and San Jose Theater is in the red.

Los Altos is a smaller community. What level of subsidy will the City be on the hook for?

Los Altos funds are depleted. Rosey statements about budget surpluses have evaporated, necessitating the City to take out a \$10M loan and freeze 6 positions which the City staff note are 'critical to accomplishing the Mission of the City.'

This is the wrong time to be funding this study.

Let's do the right homework and then consider whether the budget can or should support both the Feasibility Study and presumed subsidy.

The above referenced presentations also implied that I was speaking on behalf of the Los Altos Public Arts Commission—which I was not. This topic has never been on an Arts Commission agenda.
