## TUESDAY, MAY 13, 2025 SUMMARY OF COUNCIL ACTIONS 7:00 P.M. – REGULAR CITY COUNCIL MEETING

### **Items for Consideration**

- 1. The City Council approved the special and regular meeting minutes of April 22, 2025.
- 2. The City Council adopted a Resolution and accepted grant funding from the Citizens Option for Public Safety/Supplemental Law Enforcement Services Fund (COPS/SLESF) and authorized revenue and allocated it to the Supplemental Law Enforcement Services Fund for Fiscal Year 2024/25.
- 3. The City Council continued this item to after the adoption of a Special Events Sponsorship Policy and Process.
- 4. The City Council directed the City Attorney to draft changes to a Resolution creating a Special Events Sponsorship Policy and Process.
- 5. The City Council adopted a Resolution authorizing the increase of Solid Waste Collection Rates by 4.86%, effective July 1, 2025.
- 6. The City Council approved the formation of a City Council Ad-Hoc Committee for a Firearms Buyback Program.
- 7. The City Council adopted a Resolution authorizing the City Manager to execute the First Amendment to the Agreement for Countywide Household Hazardous (HHW) Waste Collection Program and Countywide AB 939 Implementation Fee with the County of Santa Clara on behalf of the City.
- 8. The City Council adopted a Resolution to reject all bids for the Sanitary Sewer Video Inspection, Project WW-0101, at the City Council's direction and authorized the City Manager to direct staff to rebid project.
- 9. The City Council waived First Reading and introduced an Ordinance to designate Fire Hazard Severity Zones. Second reading and adoption tentatively scheduled for May 27, 2025.
- 10. The City Council received a status update regarding gas-powered leaf blower use within the City of Los Altos.
- 11. The City Council waived first reading and introduce three separate Ordinances amending Chapter 14.50 of the Los Altos Municipal Code; repealing in its entirety the Sherwood

Gateway Specific Plan of the Los Altos Municipal Code; and amending Chapter 14.88 of the Los Altos Municipal Code and rezoning certain parcels located along San Antonio Road and El Camino Real in the City of Los Altos to Commercial Thoroughfare (CT) Zoning District. Second reading and adoption tentatively scheduled for May 27, 2025.

12. The City Council reviewed non-profit and civic organization contribution applications and directed staff to incorporate funding into the budget for FY25/26 for Compassion Week (\$5,500), Los Altos Chamber of Commerce (\$27,920), and Los Altos Mountain View Community Foundation (\$5,500).
