2. Fremont Avenue Pavement Project

Jaime Rodriguez, City's transportation consultant and Dan Leary from Bellecci and Associates presented the project design update to Fremont Avenue Pavement Rehabilitation Project. City plans to host online community outreach in August to update the community and receive final inputs on bicycle and pedestrian facility upgrades.

3. Estrellita Way and Hetch-Hetchy pathway crossing

Jaime Rodriguez presented the item to the Commission. City invited community members to the meeting to receive input on potential trail crossing improvement at Hetch-Hetchy trail and Estrellita Way. City staff proposed raised crosswalk at trail crossing to provide smooth crossing across Estrellita Way.

Engineering Services Manager Jim Sandoval and Jaime Rodriguez presented the item to Commission. Presentation included updates to some of the active and deferred transportation CIP projects.

5. Downtown Open Streets Program

6. Bicycle Facility Implementation Updates from 2020 Pavement Program

Jim Sandoval and Jaime Rodriguez presented the project status of cycle track on Almond Avenue and bike lanes on Covington Road as part of the current resurfacing project. City staff plans hold community meeting for cycle track and bike lane implementation.

City staff and Commissioners waiting on contract execution with Alta Planning for Complete Streets Masterplan.

9. Monthly Staff Report

City staff working on no-contact pedestrian push buttons as pilot program at San Antonio Road & Main Street, Covington Road & El Monte Avenue, and Main Street & 1st Street.
