2. 420 S. San Antonio Road Development Project Review
Senior Planner Steve Golden presented the item and answered questions from the Commission. Staff and the developer received preliminary feedbacks from the Commission.
3. Cuesta Drive Traffic Calming Project – Post Construction Analysis
Staff Liaison Jaime Rodriguez presented the item and answered questions from the Commission. 20 members from the public spoke on the item. Common inputs from the community included concern with the extra height on Cuesta Drive speed tables while other members acknowledged its effectiveness of reducing vehicle speed. The Commission directed City staff to observe the operation of the speed tables and vehicle volumes on side streets through Fall while improving signage and striping.

Staff Liaison Jaime Rodriguez presented the item and answered questions from the Commission. City staff to continue working with Caltrans and neighboring jurisdiction to bring this item back for Study Session.
