INTRODUCTION

Alta Planning + Design, the Complete Streets Master Plan (CSMP) consultant, has prepared Draft versions of the following documents that will feed into the Bicycle & Pedestrian Transportation being prepared as part of the CSMP. The City is requesting input from the Complete Streets Commission on these documents:

- Table of Contents
- Proposed Bicycle Network
- Pedestrian Network

BACKGROUND

The CSMP development is on schedule for development of a Draft Bicycle & Pedestrian Transportation Plan by July 2021. Public solicitation on the CSMP will continue up to that time including requesting input on the Safe Routes to School – Walk n Roll Maps, School Improvement Plan Maps, and the Concept Plan Line drawings.

At the April Complete Streets Commission meeting the Commission asked for a Table of Contents to help understand and set expectations for future content of the Bicycle & Pedestrian Transportation Plan, it is now available for Commission input.

In June the Commission will review recommended projects and review recommended project ranking based on criteria developed during the CSMP Vision Statement process. The recommended projects will be based on the prior and current pedestrian and bike plans, online input received from the CSMP project portal (www.LosAltosCompleteStreets.com), and

comments received during public engagement meetings. To help the Commission set a visual expectation of where future projects may be recommended, the City is also providing Draft versions of the Proposed Bicycle and Pedestrian Network maps.

DISCUSSION

The Proposed Bicycle and Pedestrian Network Maps of the Bicycle and Pedestrian Transportation Plan will set a vision for future planning and project implementation in the City over the next 5-7 years. The proposed networks are in alignment with Draft versions of Safe Route to School Walk n Roll maps to help create a network that links and connects community facilities. Staff is requesting input on these documents early to ensure recommended projects in June are in line with commission expectations.

The CSMP Task Force is reviewing the Proposed Bicycle and Pedestrian Network Maps in May prior to the Complete Streets Commission., Their input will be summarized during staff presentations on this item.

The commission requested a Table of Contents, which will help to identify the types of policy discussion that the Bicycle & Pedestrian Transportation Plan can both initiate and advise.
