1. <u>Commission Minutes</u>

3c. <u>Fenced-in Dog Park and Off-leash Hours Program Recommendations</u>

Vice Chair Spielman and Commissioners Morris and Eckmann presented the recommendations of the Dog Park Subcommittee of the Parks and Recreation Commission. Their report is on the Parks and Recreation Commission website:

Twenty-nine members of the public spoke; their comments are located on the attached Addendum.

Action:

Commissioner Eckmann moved that the Parks and Recreation Commission recommend that City Council consider an off-leash dog park site at Hillview Baseball Field for a trial period of six (6) months. Commissioner Dailey seconded the motion.

Chair Lindermeier proposed a friendly amendment to change the trial period to twelve (12) months. Commissioner Eckmann accepted that friendly amendment. Chair Lindermeier withdrew her amendment.

Chair Lindermeier proposed a new friendly amendment to read "nine (9) operational months." Commissioner Eckmann accepted that friendly amendment.

Commissioner Spielman proposed a friendly amendment that the phrase "subject to public health guidelines" be added to the end of the motion.

Commissioner Weinberg proposed a friendly amendment that included the phrase "PARC recommends that City Council establish" at the beginning of the motion.

After discussion and consideration on wording, the final motion voted upon was as follows:

Commissioner Eckmann moved that the Parks and Recreation Commission recommends that City Council establish an off-leash hours pilot program at Hillview Baseball Field for a trial period of nine (9) operational months, subject to public health guidelines. Approve: Lindermeier, Spielman, Yeh, Morris, Eckmann, Weinberg, Dailey. Oppose: None. Abstention: None. Motion passed: 7-0-0.

Chair Lindermeier initiated a 5-minute break. (12:23 a.m., 5/21/2020, to 12:29 a.m., 5/21/2020)

Action:

Commissioner Dailey moved that the Parks and Recreation Commission recommends that City Council not consider a fenced-in dog park until such time that a property can be identified that would not require taking existing park land out of the its current use. Commissioner Eckmann seconded the motion.

Approve: Eckmann, Dailey.

Oppose: Lindermeier, Spielman, Morris, Weinberg.

Abstention: Yeh.

Motion failed: 2-4-1.

Action:

Commissioner Weinberg moved that the Parks and Recreation Commission report to City Council that at this time, we do not believe it is appropriate to establish a fenced-in dog park at either Lincoln Park or McKenzie Park. Commissioner Dailey seconded the motion.

Approve: Lindermeier, Spielman, Yeh, Eckmann, Weinberg, Dailey.

Oppose: None. Abstention: Morris. Motion passed: 6-0-1.

Action:

Commissioner Weinberg moved that the Parks and Recreation Commission recommend Heritage Oaks Park, using the same language that was used to recommend Hillview Baseball Field.

The motion voted upon reads as follows:

Commissioner Weinberg moved that the Parks and Recreation Commission recommends that City Council establish an off-leash hours pilot program at Heritage Oaks Park for a trial period of nine (9) operational months, subject to public health guidelines.

Approve: Lindermeier, Spielman, Yeh, Weinberg.

Oppose: Morris, Eckmann, Dailey.

Abstention: None.

Motion passed: 4-3-0.
