### PUBLIC HEARING

2. **16-V-11 and 16-SC-47 – A. Ahrens – 200 University Avenue**

Variations to allow for reduced setbacks and Design Review for a two-story addition to an existing one-story house. The project includes variations to 1) allow for a side yard setback of 10 feet where 25 feet is required in the R1-20 District, 2) a setback of seven feet from the existing second living unit where 10 feet is required and 3) portions of the structure to encroach into the right side daylight plane, and design review for an addition of 1,628 square feet on the first story and 1,450 square feet on the second story. *Project Planner: Dahl*

### DISCUSSION

3. **16-SC-48 – J. Whitford – 1613 Parkhills Avenue**

Design review for a second-story addition to an existing two-story house. The project includes an addition of 337 square feet on the first story and 258 square feet on the second story.
