DISCUSSION

2. <u>15-SC-32 – M. Zaidi – 859 Clinton Road</u>

Design review for a new two-story house. The project includes 2,415 square feet on the first story and 882 square feet on the second story. *Project Planner: Davis*

Assistant Planner DAVIS presented the staff report, recommending approval of design review application 15-SC-32 subject to the findings and conditions.

Project architect and applicant Mike Zaidi of G'lush Design Associates Inc., spoke in support of the project, presented an overview of the design, and discussed the arborist report and replacement trees. There was no other public comment.

The Commission discussed the project, expressing their general support. The Commission noted that the project may want to consider reducing the depth on the rear balcony to ensure passive use and less privacy impacts, expressed concern about the left side light well being located under the front porch roof, and noted that the evergreen privacy screening should not include Cypress trees.

MOTION by Vice-Chair MOISON, seconded by Commissioner BLOCKHUS, to approve design review application 15-SC-32 per the staff report findings and conditions, and with the following additional condition:

• The Cypress evergreen screening trees shall be replaced with a different evergreen species from the City's Street Tree Planting List.

3. <u>15-SC-40 – Ali's Construction – 772 University Avenue</u>

Design review for a new two-story house. The project includes 2,205 square feet on the first story and 1,469 square feet on the second story. *Project Planner: Gallegos*
