1. <u>Design Review Commission Minutes</u>

Approve minutes of the regular meeting of April 20, 2016.

DISCUSSION

2. <u>16-SC-19 – S. Stotler – 841 Santa Rita Avenue</u>

Design review for a new one-story house that is 4,144 square feet in size. Project Planner: Dahl

Planning Services Manager Dahl presented the staff report, recommending approval of the project. Project applicant and architect Scott Stotler presented the application, requesting approval to remove of both Pepper trees and replace with new street trees. Property owners Ashna and Rahal Khurana also presented the application.

- Remove condition No. 4 and replace with a condition that requires the driveway width to be reduced and to consider design alternatives that reduce visual impact of the wide driveway from the street.

3. <u>15-SC-39 – Ali's Construction– 770 University Avenue</u>

Design review for a new two-story house. The project includes 2,508 square feet on the first story and 1,397 square feet on the second story. *Project Planner: Gallegos*

<u>Action</u>: Upon a motion by Commissioner Kirik, seconded by Vice Chair Glew, the Commission continued design review application 15-SC-39 to the May 18, 2016 meeting due to lack of access to the property.

4. <u>16-SC-01 – M Designs Architects – 1081 Miramonte Avenue</u>

Design review for a new two-story house. The project includes 2,454 square feet on the first story and 1,740 square feet on the second story. *Project Planner: Davis*

Assistant Planner Davis presented the staff report, recommending approval of the project. Property owner Zarko Maletinroject presented the application. Project applicant and architect Malika Junaid presented the project's architectural design. Landscape architect Damir Hurdich presented the project's landscape plan.

• Identify the use/function of the vent pipe in the public right-of-way. Update design of driveway as necessary if the vent pipe cannot be relocated.

5. <u>16-SC-07 – A. and L. Nichols – 1124 S. Springer Road</u>

Design review for a new two-story house. The project includes 2,190 square feet on the first story and 1,441 square feet on the second story. *Project Planner: Davis*

Assistant Planner Davis presented the staff report, recommending approval of the project, and noting additional neighbor correspondence raising concern about the project's second story bulk. Project architect Daryl Fazekas and contractor Matt Kansky presented the application.

Public Comment

Neighbors Mike Galles and Susie Cheng spoke in opposition to the project, stating concerns related to project bulk and mass, and potential privacy impacts along the rear property line. Neighbors Sam and Lenore Cam, Cindy Hiroshige, and Sri Koneru spoke in support of the project.

<u>Action</u>: Upon a motion by Vice Chair Glew, seconded by Commissioner Kirik, the Commission approved design review application 16-SC-07 per the staff report findings and conditions, with the following additional condition:

• Add additional evergreen screening trees along the rear yard and right side yard.
