2. <u>17-SC-29 – E. Sakai, AIA – 1390 Holly Avenue</u>

Design review for a new two-story house. The proposed project will include 2,710 square feet at the first story and 950 square feet at the second story with a 2,710 square-foot basement. This project was continued from the February 14, 2018 DRC meeting. *Project Planner: Gallegos*
