# 1. Design Review Commission Minutes

#### **DISCUSSION**

#### 2. 17-SC-22 – Moe Kasir – 1634 Dallas Court

Modification of a previously approved Design Review application for a second story addition to an existing two-story house. The modification includes exterior changes and a reduction to the second story addition from 401 square feet to 331 square feet and an increase in the first story addition from 421 square feet to 478 square feet. *Project Planner: Golden* 

Senior Planner Golden presented the staff report, recommending approval of a modification to approved design review application 17-SC-22 subject to the listed findings and conditions.

# 3. <u>18-SC-09 – Michael Ma – 1085 Golden Way</u>

Design review for a new two-story house. The project includes 2,577 square feet on the first story and 1,268 square feet on the second story. *Project Planner: Chao* 

Associate Planner Chao presented the staff report, recommending approval of design review application 18-SC-09 subject to the recommended findings and conditions.

Michael Ma's associate, Laya Fang, presented the project, noting that they had conducted outreach to the adjacent property owners before the meeting and requested a modification to Condition No. 2 in order to keep a wall plate height at 10 feet, six inches in the family room at the rear but, and agreed to lowering the wall plate height of the right side of the front elevation to nine feet, six inches.
