3. <u>V21-0004 and SC21-0020 - Chad Nguyen - 800 S. El Monte Avenue</u>

Variance to exceed the maximum floor area for the R1-10 Zoning district and Design Review for a two-story addition to an existing two-story house. The project includes a 1,040 square-foot addition at the first story and a 48 square-foot addition at the second story. The project includes a variance to exceed the maximum floor area for the R1-10 Zoning District by 1,600 square feet, which would preserve a 1,600 square-foot legally nonconforming barn at the subject site. The project will result in a total floor area of 5,815 square feet, where the maximum permitted floor area is 4,215.9 square feet.
