### RECOMMENDATION:

Receive report on green business practices

### **BACKGROUND**

In 2013/14, the City Council was interested in encouraging green business practices for the City and for businesses in Los Altos as one method to achieve the City's Climate Action Plan. An Environmental Commission project was to investigate the applicability of green business initiative programs to address Council's direction. The Subcommittee was also to investigate the feasibility for Green Business certification.

The project is under study along with discussions and endeavors to find ways to encourage greener purchasing and operational practices by Los Altos businesses and by the City. Subcommittee members are Commissioner Lei Yuan and Chair Hedden.

### **DISCUSSION**

The Subcommittee will present its report on the very successful Green Business Forum held on June 25, 2015 at the First Republic Bank, 400 S. San Antonio Road, Los Altos, CA from 8 - 9:30 am. The Forum was co-sponsored by the City of Los Altos Environmental Commission, the Los Altos Chamber of Commerce, The Los Altos Village Association, GreenTown Los Altos and Santa Clara County Green Business. A presentation by representatives of Santa Clara Green Business discussed the advantages of becoming a green business: 1) marketing edge among conscientious consumers; 2) be a leader and good neighbor; 3) access to the green business online marketing tools; 4) green business logo for windows and website; 5) significant savings with green business standards in electricity, water, waste removal, referrals to rebate programs and other energy efficient resources. The Forum invited businesses including retail, restaurant, services and home-based establishments to attend. Representatives from each Department of the City attended. Testimonials from Green businesses were shared along with a Q&A session. On-line applications for Green Business certification were available during the presentation. The Forum encouraged attendees and all businesses to start the application process online at www.greenbusiness.org

# The California Green Business Program

## How does a business qualify for green certification?

- The California Green Business Program established basic criteria for local counties and governments to use as a foundation for their individual green business programs. Businesses must be in compliance with all local and state laws and regulations. The local programs will assist businesses to come into compliance. Businesses can also use the <a href="www.calgold.ca.gov">www.calgold.ca.gov</a> web site to find appropriate agencies to help them with compliance.
- The criteria focus on four key areas: waste reduction, water conservation, energy conservation, pollution prevention.
- Certification criteria can vary depending on where the business is located.
- Each applicant must fulfill a checklist of improvements addressing the four key areas. Sample checklist items are listed in the table below:

# Examples of Environmental Measures - Checklist

Green Category	Required	Optional
Solid Waste Reduction and Recycling	Purchase products made of recycled content such as copy paper, toilet tissue, printer cartridges, etc.	Use double-sided printing and draft paper
Energy Conservation	Replace incandescent bulbs with CFLs or replace T12 flourescent lamps with T8 or T5 lamps	Install timers or occupancy sensors in rooms
Water Conservation	Replace older toilets with high efficiency models	Use reclaimed water for irrigation
Pollution Prevention	Use less toxic cleaning products	Stencil "No Dumping, Flows to Bay" on all your storm drains

# The California Green Business Program

### What Makes a Business Green?

- Green Businesses reduce how much CO2 they generate. CO2 is believed to be a significant contributor to global warming.
- Green Businesses conserve energy by using fluorescent lighting and Energy Star rated equipment
- Green Businesses conserve water through the use of low-flow toilets and water flow restrictors. Energy is needed to deliver water, so every unit of water conserved saves several pounds of CO<sub>2</sub>
- Green Businesses conserve natural resources by promoting public transit, biking and walking.
- Green Businesses reduce waste by recycling and composting and using materials with recycled content. Manufacturing, distributing a product or service and then handling the resulting waste requires energy usage and creates greenhouse gas emissions.
- Green Businesses use less toxic products. This provides a more safe and healthy workplace for both employees and customers.


# Green Business Program



Santa Clara County is part of the ABAG (Association of Bay Area Governments) Initiative for a regional Green Business Program. The Bay Area Green Business Program verifies that businesses meet resource conservation standards and enhanced environmental performance. General practices of Green Businesses include:

- Tracking water and energy usage and solid and hazardous waste generation
- 2. Adopting a written environmentally preferable (or green) purchasing policy
- 3. Establishing a 'green team' that can help guide efforts to green your business
- 4. Continuing management and staff training protocols, and opportunities for employee participation
- 5. Sharing green business efforts with customers; and
- 6. Communicating green practices to other businesses, with encouragement to enroll in the Program

Santa Clara County recognizes that green businesses employ standards that set them apart through increased competitiveness, operational efficiency, and employee health, productivity and morale.
