1. Commission minutes

Action: Upon a motion by Commissioner Eyre and seconded by Commissioner Halkola, the Commission, by a vote of 6 – 0, approved the minutes of the meeting of September 11, 2017.

3. Reviewed and discussed 2017/18 Environmental Commission Goals and Work Plan

Santa Clara County and Los Altos are hosting an Energy Upgrade California Home Upgrade Workshop on October 18<sup>th</sup>, 6:30 PM to 8:30 PM at the Hillview Community Center Multi-purpose room. Commissioner Weiden will attend the workshop to welcome attendees on behalf of the Commission.

Staff reported they are researching consultants to analyze the Green Building report and exploring potential partnerships with neighboring jurisdictions.

a. Anti-idling discussion

Action: After an update from the anti-idling subcommittee and discussion by the Commissioners, the sub-committee determined an educational campaign to reduce idling to be the most strategic avenue. The subcommittee will implement the following steps:

- Identify potential idling hot spots (near schools, along Main and State Streets, downtown parking lots, etc.) and conduct surveys of idling behavior.
- Consider potential regional support.
- Continue discussions with Los Altos School Representatives (High School and K-8) and the Police Department.
- Evaluate the survey data, research and discussions and recommend appropriate next steps at a future Environmental Commission meeting.
