1. Commission minutes  
Action: Upon a motion by Commissioner Hedden and seconded by Commissioner Weiden, the Commission, by a vote of 7 – 0, approved the minutes of the meeting of August 14, 2017 pending the amendment of the following:
  - Under **Public Comments on Items Not on the Agenda**, amendment of the sentence “Discussion followed the comments” to “Commissioners asked clarifying questions”.
  - Under **Review and discuss 2017/18 Environmental Commission Goals and Work Plan, item a. Anti-idling discussion, Public Comment:** Remove word “reports” and sentence “Discussion followed the comments” from the first paragraph. Also include the public’s request for a resolution “or an ordinance”.

Public Comment:  
Cheryl Weiden, Los Altos resident, spoke in favor of adopting an anti-idling resolution or ordinance, or implementing an educational campaign. She pointed to other cities as examples.  
  
Michelle Lee, member of the Youth Climate Action Team of the Loma Prieta chapter of the Sierra Club and Saratoga resident, expressed her support of an anti-idling ordinance and an educational campaign in Los Altos.

Action: After an update from the anti-idling subcommittee and discussion by the Commissioners, the sub-committee determined it needed additional meetings before moving forward with a recommendation to the Environmental Commission or City Council.

c. Green Building

After staff update from the Community Development Department, the Environmental Commission requested that staff investigate potential consultants to review the Green Building report and to provide feedback. Staff will also share the report with the SVCE Sustainability Managers Roundtable.
