1. Environmental Commission Minutes

2. Environmental Commission Work Plan

Public Comment:

- Los Altos Bullis Charter School students, Hayden Boone, Mallory Weisfeld and Aarthi Venkatraman expressed their support for (item 2a.) the adoption of an all-electric Reach Code Ordinance.
- Los Altos residents, Sheridan Foster, Connie Miller and Gary Hedden expressed support of the adoption of all-electric Reach Codes; they recommended the Commission consider and pursue including major remodels as well as new construction.

Action: Item 2a. Upon motion by Chair Weiden: The consensus of research into Building GHG emissions, Indoor Air Quality and Safety show significant improvements are made by eliminating gas fired appliances in our residences and buildings. The Environmental Commission presented Reach Code recommendations to the City Council on November 19, 2019 and Council requested consideration of an all-electric Reach Code. The Environmental

Commission Reach Code Subcommittee should finalize a Reach Code for presentation to the City Council on this basis unless its investigations and work into information and comments received prior to the May 31, 2020 close of the Public Outreach period determines that additional consideration by the full Environmental Commission is warranted. We affirm our previous Reach Code recommendation that newly constructed buildings be mostly electric (gas appliances permitted for cooking and fireplaces only) and support Council's consideration that that newly constructed buildings be all electric (no gas appliances or equipment). The Environmental Commission further affirms its recommended Electric Vehicle Infrastructure additions to the Green Building Standards including guidance provided by the City Council on November 19, 2019
