SUBJECT: Receive report and updates on Silicon Valley Clean Energy Authority (SVCEA)

RECOMMENDATION:

Receive reports and updates on SVCEA programs for Members Agency Working Group (MAWG)

BACKGROUND

Staff attends monthly Member Agency Working Group (MAWG) meetings with SVCEA and discusses updates.

DISCUSSION

SVCEA MAWG 2020 Updates:

At the January 24, 2020 MAWG meeting, the Building Decarb Joint Action Plan RFP was discussed, and the development of the RFP is anticipated for April, May, June, and to be completed by July. The Resilience RFP was discussed, and the panel may consist of evaluations of just SVCE territory or entire proposed area. The group discussed the Community Energy Resilience Plan and the California Resilience Challenge grant is due February 7, 2020. SVCE will be notified of the grant status in April or May. SVCE gave an update on the Heat Pump Water Heaters (HPWH) program and the incentives which could be similar to the pilot or be slightly lower. SVCE offers rebates to single-family and multifamily household customers if they switch from a natural gas water heater to an electric HPWH. Income-qualified households can be eligible for additional incentives. The limited rebates are first-come, first serve and available by reservation.

At the February 20, 2020 MAWG meeting, the Priority Zone DCFC (Direct Current Fast Charger) Program was discussed which offers incentives per charger for DCFC deployed near certain clusters of multi-unit dwelling (MUD) developments. SVCE created cluster maps that identify target areas in each jurisdiction and the maps were send out for review. Approximately 10 sites will be selected to receive the chargers. The Building Decarb plan RFP was completed, and the consultant contract review is scheduled for the March BOD meeting. The Heat Pump Water Heaters (HPWH) update shows that 66 out of 100 were completed/installed. All others are on a waitlist. The group received an update from John Supp on the Reach Codes developments throughout the CEC. SVCE is proposing to offer tech support and this will be discussed at the March BOD meeting.

On March 26, 2020, SVCE MAWG meeting was virtual due to the COVID-19 outbreak and Shelter in Place Order. Rocky Mountain Institute (RMI) presented on EV Charging Infrastructure costs. Major points to consider are soft costs, easements, ADA requirements and cost of trenching. SVCE announced that the Priority Zone DCFC Program has launched for multi-unit developments (MUD).

At the April 23, 2020 MAWG virtual meeting, the group received an update on the Resilience RFP, they received 19 proposals and 36 unique bids. Next steps are to enter into contract once the consultant is selected. SVCE discussed the Customer Relief & Community Resilience program draft details. SVCE BOD approved a \$10M allocation to the program, specific details are still to be determined. SVCE staff is currently drafting the program outline for the BOD meeting on May 12, 2020. SVCE also gave brief updates to the group on Streamlining Community-Wide Electrification, EV Funding, B-Rate Outreach and the Reach Codes.

SVCE Building Decarbonization Joint Action Plan 2020




