# 4. Prepayment of Public Employee Retirement System (PERS) unfunded liability.

This item is proposed as an agenda item for the joint meeting on October 14<sup>th</sup> with City Council. Briefly, the proposal is to reduce the outstanding amount due for our unfunded liability for the employee retirement program (PERS). The most current estimate from PERS of the side fund is \$5.5 million for Los Altos employees.

The City currently has a PERS reserve of approximately \$3 million. For the October 14 joint meeting with Council we have invited a representative from PERS to attend the meeting to discuss the City's options. The purpose of this agenda item is to have a brief discussion with the Commission regarding this matter prior to the joint meeting.
