## 3. <u>Hillview Community Center</u>

<u>Action</u>: Upon a motion by James Martin seconded by Martha McClatchie, the commission's feedback to the Task Force is as follows:

- a) There is concern about the financial process that took place at the task force meeting where \$10M was added to the Community Center allocation without consultation with staff and other parties. We recommend that the task force, with input from staff, evaluate and articulate the impact of a \$10M additional allocation for the community center on the 10-year capital plan.
- b) We recommend that the task force process include financial reviews and check points on its project timeline.
- c) We recommend that the task force review and test the contingency reserves in the context of the potential impact of the Sonoma and Napa county fires the worst in the state's history on future construction costs.

- d) We'd like the task force to explain the basis of the \$700/square foot construction cost number. NB: In the 2015 community center plan, the cost figure used per square foot was \$385.
- e) We recommend that the task force review and document the financial impact of various community center programmatic decisions on design costs
