#### 2. Investment Policy Review with PFM Asset Management, LLC

Monique Spyke with PFM Asset Management, LLC gave a presentation on the City's current Investment Policy compared to the requirements of California Government Code and recommended changes for 2019. Additionally, Monique provided an overview of current market conditions in the areas of 1-5 year corporate spreads, the flattening yield curve, Fed rate hike probabilities, and yield environments. After a discussion by the commissioners, the following recommended changes were advanced for the Investment Policy:
