3. <u>Update on Year End Audit</u>

Administrative Services Director, Sharif Etman, updated on the status of the Comprehensive Annual Financial Review (CAFR) and the Popular Annual Financial Review (PAFR). Tentatively, the City expects to receive the first draft of the CAFR by the week of January 4th, 2021 from our auditors, Maze and Associates. There will be a tentative presentation during Financial Commission's January meeting on Tuesday, January 19, 2021 and the

auditor will make another presentation during the following Council meeting on Tuesday, January 26. Significantly, our implementation of a new financial system has removed the previous finding of not having enough internal controls in our financial systems. The City will be preparing the PARF this year. This report will be developed after the CAFR is completed.

Financial Services Manager, Thuyet Dang, commented that in order to implement the ambitious goals and initiatives that the Commission and the Council have planned, there needs to be more resources available to staff.

4. Update on Tax Exempt Loan for Community Center

Financial Services Director, Sharif Etman, informed the Commission that the City is finalizing the signing and the escrow of the \$10,000,000.00 Community Center loan. The loan will be completed by Tuesday, December 22nd, 2020 and the funds will be wired to our accounts.

5. Other Staff Updates

Administrative Services Director, Mr. Sharif Etman and Finance Services Manager, Thuyet Dang have both submitted their resignations to the city, their last day with the City will be Thursday, January 7th, 2021.
